On the stated date and time while working security at Bad Manor I observed an extremely intoxicated male subject being removed from the bar. He appeared to be very intoxicated and had a knot on the back of his head that was steadily bleeding. I requested EMS. He did not speak coherently, but mumbled something about a girl hit him.

He was treated on scene by EMS and released after he refused transport. I later spoke with several bystanders as they left the club, and both said that the guy had been so drunk that when he tried to back up and dance on a girl he fell backwards and struck his head. I believe this would be consistent with the injuries that I observed.
