She was the transported to the Jail where she was turned over to CCSO.

After clearing the residence, [REDACTED] reported and flat screen and laptop stolen from inside the residence as well as two gold wedding bands. The front door was kicked in and damaged. She also locked a back bedroom which one of the panels was kicked so the suspects could make entry into the bedroom. The entire house was in disarray. The front and bedroom door were the only items that were damaged. The TV, wedding bands, and laptop were the only items taken. There were no serial numbers for either item. There are no suspects at this time. Photos were taken of the scene. Ofc. Carey assisted in fingerprinting the house for latent prints. Ofc. Carey was able to get a partial print from the burglary. It was entered into evidence. No further at this time.
