NARRATIVE

On 8-14-13 Units were dispatched to an armed robbery just occurred at the Family Dollar at 1005 Baxter St. On scene I met with the Assistant Manager, [REDACTED] and another employee, [REDACTED]. [REDACTED] told me she had just walked out of the store and locked up the doors at 10:30, as they do every night. She said then a man jumped out from behind the ice machine. [REDACTED] said he took a few steps forward and had a handgun in each hand. She described the guns as black, automatic pistols, saying she knew the difference between automatics and revolvers. She described the man as wearing a black hat with some sort of letters or logo on it, and a yellow scarf or piece of clothing covering his face, with a dark blue or black shirt. She could not tell if he was wearing gloves or not and said he was so well covered by clothing that she never provided me with a race, though the caller told dispatch he was possibly a Hispanic or white male.

[REDACTED] said he jumped out from behind the ice machine pointing both guns at the pair and said "Ya'll get back in there and give me every [REDACTED] thing." [REDACTED] said that she then turned to run, hitting the Family Dollar sign post and falling down. She got up, ran and slipped, again falling down. One of the times she was on the ground, she looked toward where the man had been and saw him run back down the same side of the building he had come from and then turn left, disappearing around the back of the building. If you are looking at the entrance of the Family Dollar, the ice machine she is referring to is along the right side of the building.

The other employee, [REDACTED], provided a similar account saying the man never came past the point on the sidewalk where the window begins. She said it was almost as if he knew where the security camera was and didn't want to get any closer than that point. She provided a better description of the suspect; 5'05" 200 lbs, wearing a light blue jersey style shirt and dark pants. She said he had a black stocking cap and a yellow scarf or shirt across his face. [REDACTED] said that when he appeared with the guns, she took off running across Baxter St.

CID and Forensics were called to the scene. The store manager also responded and pulled up the security footage. I could see [REDACTED] and [REDACTED] in front of the store when the robbery happened, but could not see the suspect. He would have been standing just out of camera view as [REDACTED] had stated. A black car had passed through the parking lot and turned on to Baxter St. just a few minutes before the robbery occurred.

[REDACTED] provided a signed victim/witness statement form.

[REDACTED] was injured when she fell and EMS transported her to St. Mary's Hospital for evaluation. I went to the hospital to collect a victim/witness statement form from [REDACTED]. While there, she said she had an incident on Sunday 8/11/13 where a male employee of the store, [REDACTED], was fired and made some threats to do harm to her. It is unknown if he has any connection to this incident, but [REDACTED] thought it suspicious enough to bring to our attention.

I have no suspects or further information at this time. This incident was turned over to CID for further investigation.

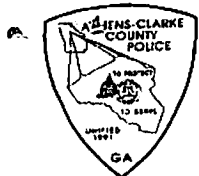
NARRATIVE

On August 14, 2013 I responded to an Entering Auto call at [REDACTED]. When I arrived on scene I spoke with [REDACTED]. She stated she parked her vehicle outside of the apartment on August 12, 2013 at approximately 2130. She returned to the vehicle today at approximately 1630 and noticed a CD cover lying on the pavement outside of her vehicle. The CD cover belonged to her. She did not drop it there. She checked inside the vehicle and noticed an insurance envelop and the cap from a perfume bottle, lying on the floor. The perfume bottle was missing along with a CD case without the CD. The missing case was from the CD cover that was lying outside the vehicle. There was no forced entry. She thinks she left the door unlocked and someone went into the vehicle.

I dusted for finger prints. I was able to locate some on the outside of the door and on the CD cover. The prints on the vehicle were lifted, placed on cards and will be turned over to evidence. The CD cover will be turned in to evidence to be processed along with the perfume cap and envelop.

[REDACTED] was given a copy of the case number for future reference. She will call back if she notices anything else missing.

NARRATIVE

I met with [REDACTED] and his daughter [REDACTED] at the PD on this date in reference to a theft that occurred. [REDACTED] stated that her ex-boyfriend [REDACTED] had stolen \$1900 dollars from her bank account over the last few months. Once he had stolen all the money in her Bank of America account an overdraft protection service kicked in and started pulling money from [REDACTED]'s Chase bank account to cover [REDACTED] account, a total of \$3208 was taken from his account.

They had print outs of three checks from [REDACTED] that he had written from [REDACTED] Chase bank to [REDACTED]. She told me that he had lost his debit card and needed money so he gave her three checks #'s [REDACTED] (\$120), [REDACTED] (\$100), [REDACTED] (\$100) to cash and get him money. She said that he was going to let her have ten dollars for each checked that was cashed. She later found out that the account had been closed and the checks bounced. Her bank charged her for these checks but she did not tell me how much the fees were.

[REDACTED] believes that [REDACTED] got ahold of her debit card and PIN to get her money. Money was pulled out using her Paypal account and several ATMS throughout Athens.

Further investigation is required.
