Notes/Narratives

NARRATIVE

On 110712 I responded to the area of 361 E. Clayton St. in reference to a fight. Upon arrival I made contact with the victim. He told me that he had been choked and assaulted. I could observe redness around the neck of the victim. I did not observe the actual altercation.

According to the victim, he saw a tattoo on the lower back of the suspect that read "tramp". The victim told me that he began to poke fun at the suspect about the tattoo. According to the victim the suspect made physical contact without provocation.

I was able to locate the suspect on Washington St., based on the description that the victim gave. According to the suspect, there was not a physical confrontation. I did not verify the tattoo.

I gave the victim the case number for this report. I explained to him the process for obtaining a warrant for the suspect. He told me at the scene that he did not have any injuries and did not need medical attention.
