Notes/Narratives**NARRATIVE**

On 011913, while on patrol, I heard over the radio that GSP unit 134 was behind a possible impaired driver. The suspect vehicle was not maintaining its lane. That unit had prisoners in the back of the car and could not stop to do an investigation. I called out that I was on the way so Unit 134 activated his emergency lights and initiated a traffic stop. The suspect vehicle, a red Dodge Ram came to a stop on Lexington Rd in the center turn lane just west of Seagraves. When I arrived the GSP unit continued on to the ACC Jail and I took over the investigation.

I made contact with the driver, identified as Gregory Ellis. He was using his passport for his id because he had lost his license. He later told me that he had lost his license two or three times lately. I had him pull over onto Seagraves Rd so that we would be in a safer place to conduct an investigation.

Mr. Ellis agreed to perform SFSTs. Based on the results of those tests I placed him under arrest for DUI and told him so. I placed him in the rear seat of my patrol car and leaving the door open read him the Georgia Implied Consent Notice for suspects age 21 or over, specifying blood for the state test. Mr. Ellis consented to the test. We went to ARMC and had his blood drawn. I transported him to the ACC Jail where he as cited and turned over to the SO. I placed the blood kit into evidence to be sent or testing.
