AFFIDAVIT OF PROBABLE CAUSE Incident # 19BB09523

NOW COMES Detective Sergeant Greg Eaton, affiant being duly sworn and on oath, deposes and says they have probable cause to believe that Laura A. Hatfield has committed the offense of embezzlement, a violation of Title 13 Vermont Statutes Annotated § 2531.

I, Greg Eaton, am now and have been since August 2009 a regular member of the Brattleboro Police Department and bring forth:

Laura A. Hatfield DOB: 11/14/1978

- 1. On 12/18/19 I met with Attorney Amelia Darrow, Power of Attorney (POA) for David W. Allen (10/20/32). I learned from Darrow that Laura A. Hatfield (11/14/78), a prior POA, had spent a significant amount of Allen's money for things that were not for Allen or his benefit. Darrow provided some bank statements and other documentation related to this case. Darrow's employee, Nicole Hammond (12/31/77), reviewed the bank statements and prepared other documentation that was also provided to me.
- 2. The POA agreement states, in part:
 I authorize my Agent to do an perform all things I could do in the transaction of any business of mine, on such terms and in such manner as said Agent may deem appropriate including, without limitation, power an authority:
 - a. Monies. To use the funds in any account of mine on deposit with any financial institution for any purpose in connection with my personal needs, support, maintenance and medical attention, or for any other purpose which my Agent, in my Agent's sole and unrestricted discretion and judgment deems in my best interest; to collect any monies due me; to make deposits and withdrawals, whether by check or otherwise; to renew or not renew any certificates of deposit; to ha full access to the contents of any and all of my safe deposit boxes; and to agree to and sign in my name any authority, signature cards, or other documents that my Agent or any institution may deem appropriate. No bank or any person shall be required to inquire into any such deposit or withdrawal made by my Agent. Any banks, trust companies, national banks, savings banks, savings and loan associations, credit unions, safe deposit companies, stock brokers, fiduciaries, depositories or other institutions, persons, firms or corporations shall act in reliance hereon and shall be fully protected even through my Agent may be self-dealing, as it is contemplated by me that such may be the case.

And

s. Other Acts. To take any and all actions on my behalf as fully and effectively as if I were personally present, other than the making of health care decisions, as defined in 18 V.S.A. § 9701, and those as specifically restricted in section 1. above.

- 3. On 2/26/20, I met with David Allen at Pine Heights in Brattleboro, VT. In an audio recorded interview, Allen detailed for me that he used to live next to Hatfield on Culberston Drive in Brattleboro.
 - a. At some point, he moved in to the Bradley House, in Brattleboro, VT where Hatfield worked and has lived in an assisted living facility since.
 - b. After approximately 5 years, Allen signed Hatfield on as his Power of Attorney (POA). Hatfield was appointed POA on July 21, 2013 and was replaced as POA on October 4, 2016 by Joseph Cook (9/11/53).
 - c. Allen stated that during Hatfield's time as his POA, she was only supposed to spend his money on him and things that benefited him.
 - d. Other than the occasional dinner, he didn't really do anything with Hatfield.
 - e. He would go on trips with other residence, like a boat trip down the Connecticut River. All of the trips were within New England. Most of the trips were in the very close geographical area of Brattleboro.
 - f. Allen said he did not fly anywhere, stay in any hotels or go out to eat other than with Hatfield.
 - g. I asked Allen if he allowed Hatfield to do those things and he said, "No, I didn't know about it."
 - h. I asked Allen if he allowed anyone else to go on any of those trips with his money. He replied "No, I didn't authorize her to spend money on herself."
 - i. He did write checks to charities once a month, but he chose the charity and wrote the check himself. The largest donation he would write was \$25.
 - j. Hatfield also sold his car at the Ford dealership where he bought if from. He was supposed to get half of the proceeds (\$600), but Hatfield told he she got a bill from the State of Vermont for almost the exact amount of his share of the sale price, so he never saw any money from it.
 - k. They did not go shopping together. Hatfield bought him a radio and pants at Walmart.
- 4. I spoke to Cook on 4/17/20 on a recorded phone.
 - a. Cook filed Allen's taxes, but the misuse of funds came to his attention when they applied for Medicaid. Cook briefly talked to Hatfield and said it was an awkward conversation. She cut the conversation off and said she retained an attorney so he didn't try talking to her any more. She said something to him about possibly paying Allen back at \$600 a month.
- 5. I received banking documents from People's United Bank through two subpoenas. Hammond, at Darrow's office, conducted the review of Allen's and Hatfield's bank statements. I have two letters from Darrow's office regarding the accounting review. One is dated July 6, 2020 and the other is dated November 10, 2020. These letters provide further details as to the amount of money that was taken out of each of Allen's accounts for the time period listed. Both of these letters are attached and incorporated by reference.
- 6. Below is a transfer summary from Allen's 3 accounts into Hatfield's account as provided by Darrow's office.
 - a. Transfers from David Allen's Account # 0830171738 (checking) to Account # 00560197993 (Laura's account) between April, 2014 and June, 2016 \$7,750.00
 - Transfers from David Allen's Account # 6500399359 to Account # 00560197993 (Laura's account) on April 11, 2014
 - c. Transfers from David Allen's Account # 4451967066 to Account # 0560197993 (Laura's account) between December, 2013 and October, 2016 \$155,745.36

- 7. I spoke to Hatfield on the phone who declined to participate in an interview. She met with me at the Brattleboro Police Department on 12/18/20, where I issued her a citation for embezzlement to appear in Windham Superior Court, Windham Division for 2/2/21.
- 8. On January 30, 2021 I dropped off a list of individual transactions that were provided by Darrow's office to nursing supervisor Celeste MacArthur (6/29/55). Celeste gave the list to the Director of Social Services, Carmen "Nina" Willson (9/16/82), who reviewed the list with Allen. Allen stated to her that he went to the Whetstone one time with Hatfield for drinks, but not dinner. He also went to the Marina with Hatfield one time for brunch. I removed the first charge for the Whetstone of \$62 and the first charge from the Marina of \$70 from the list below to represent the two known charges.. Below is the list of items that Allen did not make himself nor were made in his benefit.
