

## **Route 3 and Route 360 Roadway Improvements Richmond County Notice of Willingness**

**Find out** about a proposed road improvement and trench widening project on Route 3 and Route 360 in Richmond County.

The proposed project would extend the westbound right-turn lane and the eastbound left-turn lane at the intersection of Route 360 and Route 620 (Threeway Road) and would introduce access-management improvements along westbound Route 360. Along Route 360 eastbound, approximately 0.94 miles of trench widening is planned between Route 620 and the Welch Funeral Home to allow for the installation of edge-line rumble strips. Additional trench widening is proposed on both eastbound and westbound Route 3 to accommodate shoulder rumble strips. Rumble strips are a proven safety countermeasure specifically intended to reduce roadway-departure crashes by alerting drivers who drift from the travel lane. The project also includes construction of a new right-turn lane on Route 3 at Route 642 (Sharps Road) and a realignment of the Sharps Road connection with Route 3.

The purpose of the project is to improve traffic operations and safety.

If your concerns cannot be satisfied, VDOT is willing to hold a public hearing. You may request that a public hearing be held by sending a written request to Mr. Elyas Jalalzai, VDOT Project Manager, 87 Deacon Road, Fredericksburg, VA 22405 on or prior to, **February 10, 2026**. If a request for a public hearing is received, notice of date, time and place of the hearing will be posted.

In compliance with the National Historic Preservation Act, Section 106 and 36 CFR Part 800, information concerning the potential effects of the proposed project on properties listed in or eligible for listing in the National Register of Historic Places is provided in the environmental documentation.
