Find out about the proposed project to construct sidewalk on the east side of Route 38 (Five Forks Road) which will connect existing sidewalk from the Amelia County Elementary School to the Amelia Court House Village.

The meeting will be held in an open house format from 5:30 to 7 p.m. This format will provide the flexibility to allow participants to meet and discuss the proposed project directly with project staff members.

Review information, project plans regarding the proposed modification, and the National Environmental Policy Act document in the form of a programmatic categorical exclusion at the hearing and VDOT's Richmond District Office located at 2430 Pine Forest Drive, South Chesterfield, VA 23834-9002, 804-524-6000, 1-800-367-7623 or TTY/TDD 711. Please call ahead to ensure the availability of appropriate personnel to answer your questions. Property impact information, relocation assistance policies and tentative construction schedules are available for your review at the above address and at the public hearing.

As the project's design is developed and finalized, VDOT will determine the location of the right of way and/or easements that will be needed to accommodate construction of the project and future maintenance. The property owners that are affected by right of way acquisitions will be notified of the proposed location of the right of way and/or easements needed during the right of way acquisition process and prior to construction of the project. Right of Way acquisition will be performed in accordance with the Federal Uniform Relocation Assistance and Real Property Acquisition Policies Act and all applicable federal and state laws, and VDOT policies and standards.
