

# Wilson Road Bridge Replacement over Namozine Creek in Dinwiddie County

## *Willingness to hold a public hearing*

Find out about plans to replace the existing Route 639 (Wilson Road) bridge over Namozine Creek connecting Dinwiddie and Nottoway counties. The new bridge will be a single span made of concrete beams with an asphalt overlay and will allow for one lane of traffic in each direction with shoulders. Work will also include guardrail installation and widening of roadway approaches to match the proposed bridge width.

Review information such as project plans and the National Environmental Policy Act document in the form of a programmatic categorical exclusion at VDOT's Richmond District Office located at 2430 Pine Forest Drive, South Chesterfield, VA 23834-9002, 804-524-6000, 1-800-367-7623 or TTY/TDD 711. Please call ahead to ensure the availability of appropriate personnel to answer your questions. Property impact information, relocation assistance policies and tentative construction schedules are available for your review at the above address and at the public hearing.

As the project's design is developed and finalized, VDOT will determine the location of the right of way and/or easements that will be needed to accommodate construction of the project and future maintenance. The property owners that are affected by right of way acquisitions will be notified of the proposed location of the right of way and/or easements needed during the right of way acquisition process and prior to construction of the project. Right of Way acquisition will be performed in accordance with the Federal Uniform Relocation Assistance and Real Property Acquisition Policies Act and all applicable federal and state laws, and VDOT policies and standards.

If your concerns cannot be satisfied, VDOT is willing to hold a public hearing.
