The Office of the State Inspector General (OSIG) is conducting a special review of the Bon Air Juvenile Correctional Center. At a minimum, the objective of this special review will include:

- Reviewing operations at the facility.
- Reviewing the adequacy of staffing.
- Reviewing programming provided to the residents.
- Reviewing mental health services provided to the residents.

OSIG's preliminary work will include gaining an understanding of the Bon Air Juvenile Correctional Center and the daily operations of the facility. The preliminary methodology will consist of touring the facility, interviewing key staff members, and documenting processes and procedures related to facility operations.

At the conclusion of the review, OSIG will provide a draft report to the Department of Juvenile Justice (DJJ) containing significant observations, if any, and will conduct an exit conference to provide DJJ agency management the opportunity to comment on the report and provide their plan of action in response to OSIG's recommendations. OSIG will distribute the final report, with management's responses and plan of action, to the Governor's office, the Commission on Youth, General Assembly, and the Secretary of Public Safety and Homeland Security by

December 1, 2025, with copies to the appropriate officials of your agency. OSIG will also post the report on its website.

OSIG Audit Manager Nancy Edmunds and auditors Sidney Stewart and Madison McRae will be performing this review. Sidney Stewart will contact your office to arrange an entrance conference to discuss the details of this project and identify agency employees to serve as contacts.
