The Transportation Division of Chesterfield County Public Schools admits that it does not carry IEPs/504s on Buses/Transportation for Special Education Students. All Special Education Service Providers must have access to IEPs at all times in order to follow IEPs/504s (IEP = FAPE + ADA). Not only will Bus/Transportation Drivers/Aides NOT have available instructions in the event of behavioral considerations, and how to follow IEPs for any support/interventions, it is critical that ALL providers of services have access to any 504 portions of IEPs AND the proper tools/equipment to assist in the event of such possibilities as, but not limited to, seizures, anaphylactic reactions and any and all medical interventions, which is a RISK TO THE SAFETY OF ALL IEP/504 Scholars. THIS IS IN VIOLATION of 34 C.F.R. 300,323 (d) at a minimum.

The CCPS School Board is out of compliance in that not ALL Service/Support providers have IEPs at hand to ensure

compliance for Behavioral and/or Medical Interventions as required in transit to/from school and/or School Sponsored Activities at all times. Included is a recording from Transportation, the Special Education Transportation Office.

6. Provide a proposed resolution of the problem to the extent known and available.

A. CCPS will immediately train and no less than SEMI-ANNUALLY ALL Providers of Transportation and Leadership, Superintendents/Chiefs/Directors, and School Board Members, and including Third Party Transporters, on IDEA Compliance concerning Transportation. VDOE will document this training as evidence of compliance enforcement and assure Public Awareness of the Corrective Actions, as many parents may not be aware that ALL Service Providers MUST have access to IEPs at all times for support and to avoid denials of FAPE. VDOE can choose to prescribe training for ALL LEAs Across Va.

- B. CCPS will update its Special Education Handbook and Policies and Procedures and its Transportation Division with policy and language to ASSURE that ALL Services/Education Providers MUST have IEPs (and 504 Plans) accessible at all times for IDEA compliance and enforcement and that ALL providers are adequately trained for the needs of each specific child and document the necessity of compliance with 34 C.F.R 300.323(d) This US Code must be referenced.
- C. Written Assurance from Chesterfield County Public Schools to the VDOE AND the State Complaint Submitter, actions that CCPS will take to prevent Non-Compliance moving forward with fidelity.
- D. Submitter requests ALL communications regarding the complaint/enforcement to be sent to the State Complaint Submitter, . (There should not be a lack of transparency in the production of State Complaints at any stage).
- E. State Complaint Submitter requests compensation of \$100,000 by the LEA for enacting the State Complaint and follow-up required to assure the SAFETY of ALL Chesterfield County Public Schools Scholars who utilize Transportation provided by and/or paid for by the LEA.
- F. VDOE does NOT have permission to share this information which includes PII EXTERNALLY of VDOE.
- G. State Complaint Submitter is OPEN to a Resolution Meeting with the Interim Superintendent, Dr. John T. Murray directly. If successful, State Complaint Submitter \*may\* agree to withdraw the State Complaint. A Resolution \*may\* provide for the RIGHTS of Students and their SAFETY far more efficiently and swiftly than State Complaint constraints and length of time VDOE indicates for compliance, which is TOO lenient for FAPE violations and SAFETY matters, when 'no greater than one year'....
