METHODS:

- The method of deoxyribonucleic acid (DNA) analysis used was the Polymerase Chain Reaction (PCR) performed by The Bode Technology Group, Inc. on evidence retained in the case file.
- The PCR amplification kit used was the PowerPlex[®] 16 BIO system.
- The PowerPlex[®] 16 BIO system contains 16 genetic loci (FGA, TPOX, D8S1179, vWA, Penta E, D18S51, D21S11, TH01, D3S1358, Penta D, CSF1PO, D16S539, D7S820, D13S317, D5S818 and Amelogenin, a gender determining locus which is not used for statistical purposes).

RESULTS:

DNA profiles were obtained for Jens Soering [REDACTED] from the Virginia DNA Data Bank.

- These sample profiles were used for investigational purposes only.
- Whenever Data Bank samples are used for such purposes, a confirmation must be performed. This requires the submission of two buccal (cheek) swabs from Jens Soering [REDACTED].
