

I have also asked Kenny Weeks as I mentioned yesterday to further investigate the isolation of the containment area. To ensure that if we did have either an over fill of the tanks or a rupture that we are conformable knowing that it is contained within the area and not discharged to water of the states. I have also asked that there is an immediate retraining of all employees on the excepting of chemicals and the filling of tanks.

Also just FYI the initial inspection from the Environmental contractor's that responded yesterday to pump out the contaminated chemicals from the tanks feels the tanks integrate remains intact and no adverse effect to the tanks occurred.

> The first 3 measures listed above minimize most of the risks associated with having a mix up. Today's event was a lack of effort on the operations shift/staff to do the right thing. What can I do to improve the situation? I am not sure how much training and retraining can be done to prevent another mix up from happening. We had 3 class 1 waterworks operators here today and it still happened.

. This is the root cause of the failure.

My perspective of this situation is operations had a failure today that was 100% preventable. We did not follow the procedure. We did not care to follow the procedure. At that point we have a lack of responsibility and a lack accountability for ourselves and the internal and external customers we serve. I have to be responsible for the operations staff to conduct business the right way. Today that did not happen.

> What am I going to do to minimize the risk of this occurring again? We have a sop that has been around for a long time. We offer training to our operators. We have several checks in place. This problem is about correcting the mistake. Calling it a mistake is a cheap way of trying to get out of trouble. This is a bigger issue of are we really holding ourselves and our direct reports responsible for conducting their duties the proper way? The answer for today is no. We failed today.

> The first 3 measures listed above minimize most of the risks associated with having a mix up. Today's event was a lack of effort on the operations shift/staff to do the right thing. What can I do to improve the situation? I am not sure how much training and retraining can be done to prevent another mix up from happening. We had 3 class 1 waterworks operators here today and it still happened.

. This is the root cause of the failure.

My perspective of this situation is operations had a failure today that was 100% preventable. We did not follow the procedure. We did not care to follow the procedure. At that point we have a lack of responsibility and a lack accountability for ourselves and the internal and external customers we serve. I have to be responsible for the operations staff to conduct business the right way. Today that did not happen.

> What am I going to do to minimize the risk of this occurring again? We have a sop that has been around for a long time. We offer training to our operators. We have several checks in place.
