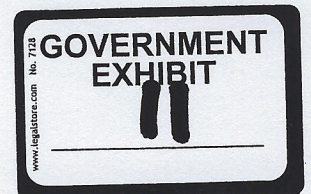

I was able to call [REDACTED] I recorded the conversation on my BWC under the original CAD#.

I was able to obtain more details about the situation which is as follows:

[REDACTED]

He stated that "Chapín" showed him two long guns on 6-21-22 in the evening hours. The first long gun was an AR style with 6 metal magazines and was equipped with a red dot sight under the barrel.

The second long gun was a higher caliber than the first. The barrel was longer and had several holes on the handguard. It also had a two leg kickstand.

[REDACTED] was told by the subject that he was planning on shooting up a large gathering event on July 4th. No specification on what time or location.

The subject is associated with a Mexican gang call "Los Zetas" (The Zs), and used to be an enforcer within the gang. He also fires the rifles through out the week in his back yard.
