Enrollment Statistics Assumptions

The following document contains a series of tables and maps that depict statistics for current schools and boundaries, as well as redistricting options that are being evaluated. This information will help inform all committee members on how schools could be potentially impacted as a result of potential redistricting adjustments, along with a comparison to current school information

The following provides a general overview to the changes in Elementary School Draft Rezoning Options. It should be noted that different concepts from the options could be leveraged/combined to make a more optimal option, if the committee sees fit. The options are summarized by the following regions of the district for elementary schools:

Elementary Option A

Elementary Option A takes a conservative approach to rezoning, in that it only encompasses rezoning of boundaries, with no consideration of school pairing, closures, or consolidation.

Southeast: Rezoning option that affects Blackwell ES, Greene ES and Broad Rock ES. Other schools in this area (Francis ES, and Oak Grove ES) are unaffected in this option.

South-Central: Westover Hills ES sends students to Blackwell ES. Other schools in this area (Swansboro ES, Redd ES, and GH Reid ES) are unaffected in this option.

Southwest: Southampton ES adds students from Miles Jones ES. Fisher ES is unaffected by rezoning as their utilization is near optimal, and they are geographically located in an area that is prohibitive in providing relief to other schools without rezoning areas immediately next to the schools that they would draw from.

Northeast: Rezoning neighboring schools into George Mason ES, to effectively utilize the newly built school's capacity and provide relief to other schools in the area.

North-Central: Carver ES helps provide capacity relief to Holton ES. Also, adjustments were made between Cary, Fox, and Carver ES to balance utilization. Obama ES receives some area from Ginter Park ES, so Ginter Park can help provide relief to Holton ES.

Northwest: Holton sends students to both Carver and Ginter Park ES. No change to Mary Munford zone. The overcrowding that exists at Fox and Mary Munford could be resolved by reducing the number of students attending from out of zone.



Elementary Option B

Elementary Option B incorporates some more moderate concepts of school pairing in addition to rezoning, with a focus on balancing utilization and helping to better diversify schools.

Southeast: Rezoning option that affects Greene ES, Broad Rock ES, Francis ES, Oak Grove ES, and Blackwell ES.

South-Central: Westover Hills ES sends students to Blackwell ES. Other schools in this area (Swansboro ES, Redd ES, and GH Reid ES) are unaffected in this option.

Southwest: Southampton ES adds students from Miles Jones ES. Fisher ES is unaffected by rezoning as their utilization is near optimal, and they are geographically located in an area that is prohibitive in providing relief to other schools without rezoning areas immediately next to the schools that they would draw from.

Northeast: Rezoning neighboring schools into George Mason ES, to effectively utilize the newly built school's capacity and provide relief to other schools in the area.

North-Central: Cary and Mary Munford are paired together in this option, and Carver and Fox are paired together with a focus on balancing building utilization and improving the overall diversity of all schools. Munford will become K-2nd, and Cary will become 3-5th. Fox will become K-1st and Carver will become 2-5th. Obama ES receives some area from Ginter Park ES, so Ginter Park help provide relief to Holton ES.

Northwest: Ginter Park and Holton are paired together in this option with a focus on balancing building utilization and improving the overall diversity of all schools. Holton will become K-2nd and Ginter Park will become 3-5th.

Elementary Option C

Elementary Option C incorporates some more moderate concepts of school pairing in addition to rezoning, with a focus on balancing utilization and helping to better diversify schools.

Southeast: Rezoning option that affects Greene ES, Broad Rock ES, Francis ES, Oak Grove ES, and Blackwell ES.

South-Central: Westover Hills ES sends students to Blackwell ES. Other schools in this area (Swansboro ES, Redd ES, and GH Reid ES) are unaffected in this option.

Southwest: Southampton ES adds students from Miles Jones ES. Fisher ES is unaffected by rezoning as their utilization is near optimal, and they are geographically located in an area that is prohibitive in providing relief to other schools without rezoning areas immediately next to the schools that they would draw from.

Northeast: Rezoning neighboring schools into George Mason ES, to effectively utilize the newly built school's capacity and provide relief to other schools in the area.

North-Central: Cary and Fox are paired together in this option, with a focus on balancing building utilization and improving the overall diversity of both schools. Fox will become K-3rd, and Cary will become 4-5th. Carver ES also receives area from both Cary and Fox to help balance utilization in the region. Obama ES receives some area from Ginter Park ES, so Ginter Park help provide relief to Holton ES.

Northwest: Barack Obama, Ginter Park and Holton all three work together to focus on balancing building utilization and improving the overall diversity of both schools. Obama and Ginter Park will both be K-2nd zones both feeding in to Holton for 3-5th grade. No change to Mary Munford zone. The overcrowding that exists at Fox and Mary Munford could be resolved by reducing the number of students attending from out of zone.

Glossary of Terms

Capacity -the number of students that an individual school has the physical capacity to enroll and can be reasonably accommodated in a facility.

Utilization - Utilization is the enrollment divided by the capacity, described as a percentage.

Live-in students - Students residing inside of a school attendance boundary, regardless of where that student attends school.

Live and Attend-in students - Students that live inside a school attendance boundary, and attends that school.

Live-out Attend-in students - Students that live outside of the 2018-19 attendance boundaries for the school that they attend, but attend that school.

Out of District students - Students that live outside of the Richmond Public Schools boundary.

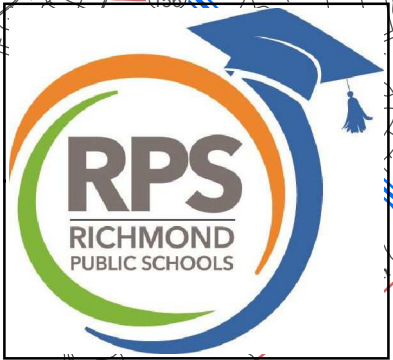
Unmatched students - Students whose address was not able to be located by the GIS.

Estimated Enrollment - Estimated Enrollment is calculated by adding the Live and Attend-in students plus the Live-Out Attend-In, Out of District, and Unmatched students.

Option Impact - The number of Live and Attend-In students that change attendance boundaries from the 2018-19 attendance boundaries given each option. In other words, an estimate of the total number of students that could be impacted per any of the options.

Feeder Pattern - The number of students living within the attendance boundary of both a lower grade cohort (ex. Elementary schools) and a higher grade cohort (i.e. Middle School). This is given as both the number of Live and Attend-in students, and described as a percentage.

Elementary Zones 2018-19



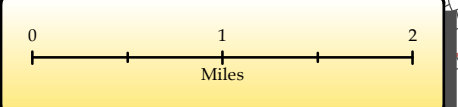
