## **Matko slaying** case could go to jury today

No motive has been presented for Chesterfield teen's killing

Cell-phone records, a pair of sneakers, a murder weapon sold four times, and a clinical look at how 16-year-old Ryan Matko died became the focus of Detavis J. King's murder trial yesterday as prosecutors wrapped up their case.

In calling 18 witnesses over two days and stipulating the testimony of three others, Chesterfield County prosecutors laid out what they believe were the circumstances that led to the Chesterfield teenager's death Aug. 22, 2007.

But why Matko was killed remained elusive. Prosecutors may articulate their theory in closing arguments this morning, on the trial's

A gang-related motive pushed by prosecutors was rejected early in the case when Judge Frederick G. Rockwell III blocked any mention of King's gang ties to the Bloods. An admitted gang member, King, now 18, has acknowledged selling small quantities of marijuana to Matko, whom he once described to investigators as a "cool dude" and friend.

At the end of yesterday's proceedings, defense attorney Greg Sheldon told the court he

CHARLOTTESVILLE — More than 1,300 residents packed Charlottesville High School's auditorium last night to deliver their views on health-care reform to U.S. Rep. Tom Perriello.

# Amended plan will keep Varina rural



### Supervisors follow suggestions to maintain agricultural character

Henrico County's path to the future will not follow Interstate 295 south all the way to the river with suburban development.

Supervisors unanimously voted last night to adopt the 2026 Comprehensive Plan, with amendments to mollify concerns of Varina residents who want to keep their end of the county rural.

Varina Farm will remain a farm in 2026, instead of a Suburban Mixed Use development, according to

the final version of the plan. The county also will retain separate designations for rural residential and prime agricultural land.

"What we did was sidestep a disaster," said Nicole Anderson Ellis, who has been a vocal proponent for open space as a mem-**BREAKING** ber of Envision Henrico. **NEWS** "It's not about who won or lost. It's

After the decision was final, Ellis said: "Sometimes when you voice public opinion, you've got to shout.' Gatewood Stoneman and members of her family,
