Two Suspects Arrested For Trafficking Heroin Enroute To Rocky Mount

On Monday 04-04-2022 at approximately 1100 hours, Sheriff Stone was travelling Eastbound on US 64 near the 460 mile marker, when he observed a vehicle travelling too close behind another vehicle (NCGS 20-152) and observed the driver texting on his phone (NCGS 20-137.4a). Sheriff Stone made a traffic stop of the vehicle and made contact with the two occupants. While speaking with the two occupants, Sheriff Stone believed criminal activity to be present based on their behavior and discrepancies in their travel arrangements. Deputy M. Hasty, along with Deputy T. Mooring and his partner K-9 Kieser arrived to backup Sheriff Stone.

Deputy Mooring deployed K-9 Kieser on the vehicle to conduct a free air sniff of the vehicle. K-9 Kieser gave a positive alert to the odor of narcotics on the vehicle. K-9 Kieser then conducted a sniff of the interior of the vehicle and gave a positive alert to a camera bag located on the back seat of the vehicle. A subsequent search of the camera bag revealed 25 "bricks" of Heroin, or 1,250 individual "bindles" or dosage units. Both suspects were detained, and it was determined that they were travelling from Raleigh to the Rocky Mount area to deliver the Heroin.

Both of these suspects have criminal histories for drug sales and trafficking in New Jersey from the past. MANN has been charged with Possession of a Controlled Substance in 2017 in New Jersey. JONES has a lengthy criminal history dating back to the age of 15 years of age including weapons charges, drug charges and assault charges, including serving prison time as an adult.
