On Thursday July 20, 2023, The Nash County Special Response Team, (SRT), executed a search warrant at 172 King Charles Court, Rocky Mount, in reference to an ongoing investigation into the sales of Fentanyl/Heroin. The Nash County Sheriff's Office had received multiple complaints of the ongoing selling of Fentanyl/Heroin and Cocaine out of this residence. During the execution of the search warrant the Nash County Sheriff's Office recovered several dosage units of Heroin and 13 grams of Crack/Cocaine. Tyrone Gray was arrested and charged with the following:

On Thursday July 20, 2023, The Nash County Special Response Team, (SRT), executed a search warrant at Hal Orr's Motel Room 70 for the selling of Heroin/Cocaine by ANDY DANIELS. DANIELS in the past week had a previous search warrant executed on the same room for the selling of Heroin/Cocaine, discovering an unidentified female that was actively overdosing, along with Cocaine and a handgun. On Thursday July 20, 2023, The Nash County Sheriff's Office executed a search warrant at 710 S Pine St Rocky Mount in reference to an ongoing investigation into the selling of Fentanyl/Heroin by JAHQUEL CUTLER.
