### **Suspect Pleads Guilty to 2<sup>nd</sup> Degree Murder in Death of his Wife**

On Tuesday March 1st, 2022 Alexander Dayton Dzikowski pled guilty to 2nd Degree Murder in the death of his wife, Tiara Laquan Dzikowski.

District Attorney Robert Evans presented the plea arraignment today in Superior Court to the Honorable Quentin Sumner. District Attorney Evans noted that the State and the family had agreed to the plea in order to keep the children who witnessed the horrific tragedy from having to relive the emotional and traumatic event. Superior Court Judge Sumner accepted the plea arraignment and sentenced Alexander Dayton Dzikowski to no less than 313 months to no more than 373 months, (26-31 years) in a state penitentiary.

### **Previous Press Release: Domestic Disturbance Results in Death**

On Sunday 12-06-2020 at approximately 10:15am, Patrol units of the Nash County Sheriff's Office were dispatched to 4678 Pine Street, Battleboro in reference to a 911 call about an unconscious subject. While enroute, Deputies were advised that the children of the residence had gone next door to a neighbor's house and stated that the victim had been stabbed by the suspect. Once arriving on scene, the suspect was taken into custody without incident.
