### **Suspect Charged with Multiple Narcotics and Firearms Charges After Search Warrant**

On Monday 05-30-2022, members of the Nash County Sheriff's Office Patrol Division assisted Nashville Police Department with the execution of a search warrant at 1580 Strawbush Court, Spring Hope. The purpose of the search warrant was based on an investigation into the larceny of multiple firearms from within the town limits of Nashville.

Upon execution of the search warrant, Deputies discovered multiple indicators of illegal narcotics activity. A second search warrant was applied for, and received by the Nash County Sheriff's Office for a search for narcotics in the residence. During the search, a total of eight (8) firearms, fourteen (14) grams of Fentanyl, twenty (20) grams of Methamphetamine, thirteen (13) grams of Marijuana, and narcotics equipment and paraphernalia was seized.

A suspect, Kenneth Brandon Pomeroy was arrested and charged with multiple weapons and narcotics charges. He was placed into the Nash County Detention Center under a \$200,000 secured bond, with a First Appearance hearing on 05-31-2022. At the time of this release, he is still incarcerated in the Detention Center.

The Nashville Police Department will have further information and charges as it relates to the initial larceny of firearms investigation. This case started out as an investigation into stolen guns, but resulted in a significant narcotics arrest. As Sheriff Keith Stone has noted in the past: gangs, guns and drugs are the driving factors behind crime in our area. Collaboration between agencies, as seen in this case, is vital to combatting crime in our community.
