**DECLARATION IN SUPPORT  
OF WARRANT OF ARREST**

The undersigned hereby declares:

That they are a Peace Officer employed as a Special Agent for the New Mexico Department of Justice; that pursuant to their employment, they have been assigned to investigate allegations that the offense(s) of **30-09-11((D)1) to wit: Aggravated Criminal Sexual Penetration of a Minor, 30-09-13(B)1) to wit: Criminal Sexual Contact of a Minor, 61-06-20(A) to wit: Practicing without License, and 30-03-04 to wit: Battery**, committed by: **Jared Cordum** [REDACTED],

That your Declarant has personal knowledge as herein stated and has obtained information from various other persons not herein stated regarding the above alleged offense(s); and that as to those matters which are not within your Declarant's personal knowledge, your Declarant is informed and does believe that the matters stated and set forth herein are true.

In the following affidavit, the identified victims in this investigation are under the age of 18. Contained within the affidavit, the child victims are identified as "John Doe" with a preceding number. The child victim's real names are known to Agents and the Affiant but will be referenced in this affidavit as "John Doe."

On May 3, 2024, I was assigned to assist Clovis Police Department in reference to numerous complaints filed against an Occupational Therapist identified as Jared Cordum. These complaints were filed by parents regarding the treatment their children received from Mr. Cordum.

Affiant learned that on February 22, 2024, Officer Timothy Orum with the Clovis Police Department responded to [REDACTED] in reference to a reported Criminal Sexual Penetration of a Minor. Officer Orum contacted the reporting party and school therapist, Amy [REDACTED]. Ms. [REDACTED] stated the foster mother of an eight-year-old student, Armanda [REDACTED], advised her foster child, referred herein as "John Doe 1" might come in and state someone put something in his rectum. Ms. [REDACTED] stated Armanda advised her not to worry about this incident since it was done as a medical procedure. Ms. [REDACTED] stated she did not feel good about the incident, and contacted her boss, who requested she find out who this procedure was done by, a doctor or an occupational therapist. Ms. [REDACTED] stated she contacted Armanda and was advised the procedure was done by an occupational therapist identified as Jared Cordum. Armanda reported Jared Cordum gave the child an enema. Ms. [REDACTED] stated she called her boss and was advised to make a report. Ms. [REDACTED] reported this incident.

On March 1, 2024, Detective Honorato with the Clovis Police Department conducted an interview with the foster mother of John Doe 1, Armanda [REDACTED]. During this interview two CYFD personnel present, Rebecca Garcia, and Janelle Hammond. Armanda stated an appointment was set up with Mr. Cordum from Outside the Box Therapy due to John Doe 1's issues in which he urinates and defecates on himself, as well as behavior issues and fine/gross motor skill issues. Armanda stated the referral was given by Dr. Jeffcoat, who is John Doe 1's primary care pediatrician for Outside the Box Therapy. It was explained that John Doe 1 suffers from a TBI from shaken baby syndrome, and an issue with one of his arm/hand areas.

Armanda stated around the month of February, 2024, during the first appointment with Mr. Cordum, which occurred in their home located at [REDACTED]. Armanda stated Jared Cordum performed an ultrasound on John Doe 1's stomach, and buttocks, specifically the butt cheek area.

Armanda stated she never saw a therapist do this kind of treatment, and asked Mr. Cordum if he was qualified for this, and Mr. Cordum responded that is his position and he is indeed qualified for it. Armanda stated Mr. Cordum advised there was poop stuck in John Doe 1's belly and that is why he urinates and defecates when he falls asleep and relaxes. Armanda stated, Cordum instructed her to start massaging John Doe 1's stomach in a counterclockwise manner to move the poop, and it will assist it in moving out. Armanda stated she tried this, and he did defecate.

Armanda stated during the next appointment which occurred at her home located at [REDACTED], which was around the time of February 22, 2024, Mr. Cordum performed another ultrasound on John Doe 1. It was stated due to John Doe 1's body structure and posture, the feces weren't coming out.

Armanda stated during this same visit Jared directed John Doe 1's to remove his pants. John Doe 1 was naked from the waist down. Armanda stated John Doe 1 was on his back, and Mr. Cordum put an electrode sticker on John Doe 1's inner leg, and buttock area near the rectum. Armanda stated Jared Cordum inserted an enema into John Doe 1, and it did not work for John Doe 1. Armanda stated Mr. Cordum was demonstrating on John Doe 1 how to perform the enema, and she would do them in the future. Armanda stated after this, she canceled all future appointments. Armanda further stated the school therapist, Amy [REDACTED] was not comfortable with Mr. Cordum's treatment, and she Armanda did not comfortable continuing with service as she did not know what Cordum was or was not allowed to do.

Armanda stated the School Therapist, Amy [REDACTED], called her questioning if Mr. Cordum could be practicing on John Doe 1, and Armanda responded she did not know what Mr. Cordum's job was and didn't question him.

On March 13, 2024, a safehouse interview was conducted with John Doe 1 at [REDACTED], which was reviewed by affiant. This interview was conducted by Erica Morrison. After speaking to John Doe 1 for a short time, the Morrison asked John Doe 1 if he knew why he was at the interview, or what they were going to talk about. John Doe 1 stated no but stated he knew he had a doctor's appointment.

Morrison asked John Doe 1 if he goes to the doctor a lot and he stated no, but only when needed. Morrison asked John Doe 1 if anyone goes to Mrs. Armanda's house to work with him and he stated yes, saying "Jared". Morrison then asks John Doe 1 about the things he does with Jared. John Doe 1 responds by pointing to his chest, then stomach area and then his buttocks area. Morrison asked John Doe 1 what it meant when he pointed to his chest and John Doe 1 says no, right here (pointing to his stomach) and right here (pointing to his buttocks again). Morrison asks John Doe 1 what happens in those areas and John Doe 1 says Jared checks him to see if he is fine. Morrison again asks John Doe 1 what those areas are, and John Doe 1 says his stomach and butt.

Morrison asks John Doe 1 what Jared checks to see if he is fine, and John Doe 1 stated he doesn't know. Morrison asks John Doe 1 if he's fine and he states yes, saying that everyone is nice to him. Morrison asks John Doe 1 what Jared does to make sure he's fine and he responds saying he forgot. Morrison also asked John Doe 1 of what other things he does with Jared, and he states he forgot as well. Morrison asks John Doe 1 who's with Jared when he checks him, and he stated Mrs. Armanda.

Morrison asks John Doe 1 what Mrs. Armanda does, and he responds saying he ran naked in the kitchen one time with Jared. Morrison asks John Doe 1 what happened when he ran into the kitchen naked, and he responds saying "Jared told me to". Morrison asked John Doe 1 what else happened and he stated he doesn't know. Morrison asked John Doe 1 where Mrs. Armanda was at when he was running naked in the kitchen, and he stated in his, John Doe 1's room. John Doe 1 said Jared then told him not to go to school, so he didn't go. Morrison asked John Doe 1 why Jared told him not to go to school and he said he didn't know. Morrison asked John Doe 1 about how Jared checked his stomach and buttocks area, and he states jelly for the stomach area and three stickers for his buttocks area. Morrison asked John Doe 1 of how Jared makes him feel and he responds "good". The interview then ends with John Doe 1 no longer wanting to talk.

On June 25, 2024, I interviewed Elizabeth [REDACTED] mother of a 4-year-old juvenile male, John Doe 2. Elizabeth stated John Doe 2 had a follow up appointment on April 12, 2024, with Dr. Schoof and was referred to Out the Box Therapy. Elizabeth stated the initial appointment with Dr. Schoof was because John Doe 2 was admitted the previous week due to issues using the restroom. Elizabeth stated there was an impaction, and they sent home laxatives and a suppository, which were not effective.

Elizabeth stated she contacted Jared Cordum and set up an in-home appointment for occupational therapy at her home located at [REDACTED].

Elizabeth stated on April 24, 2024, Mr. Cordum came to her house for an arranged appointment. Elizabeth stated her first impression of Mr. Cordum was that he gave her "weird energy". Elizabeth stated she pushed these emotions down and trusted him as a professional. Elizabeth stated John Doe 2 is nervous regarding anything that involves potty training and did not want to leave his room. Elizabeth asked if Mr. Cordum could do it (conduct the appointment) in the room, and Mr. Cordum agreed.

Elizabeth stated once in the room, Mr. Cordum brought in equipment, and was explaining it to John Doe 2. Elizabeth stated Mr. Cordum wanted to start with an X-ray and had the capability utilizing one of his electronic devices, connected to a laptop. Elizabeth stated Mr. Cordum asked John Doe 2 to take off his shirt. John Doe 2 did not want to take his shirt off, and Elizabeth had to call him over to help him take his shirt off. Elizabeth stated this was odd to her because she had many ultrasounds, and she personally never had to take her shirt completely off. Elizabeth stated Cordum told her there was still the impaction and enlarged colon.

Elizabeth stated Mr. Cordum proceeded to take out electrode stickers, and initially placed them on John Doe 2s arm. Elizabeth said Mr. Cordum explained this gives him "Biofeedback." Elizabeth said Mr. Cordum told her he was going to putt the electrode stickers on John Doe 2's butt, and butt muscles near his rectum. Elizabeth said Mr. Cordum had John Doe 2 take his pants off, and at this point John Doe 2 is fully nude. Elizabeth said Mr. Cordum then placed the electrode stickers on John Doe 2's buttocks and told him to hold like he was holding his stool. Mr. Cordum indicated he was getting biofeedback. Elizabeth said Mr. Cordum then asked John Doe 2 to push like he was pushing a stool out and was getting the biofeedback for that as well.

Elizabeth stated John Doe 2 was very uncomfortable the entire time, but she was trusting what she believed to be a professional.

Elizabeth stated Mr. Cordum then instructed John Doe 2 to get into a pose that resembled "Childs Pose" which is described as a position where you are on your hands and knees, leaning forward. Elizabeth said Mr. Cordum needed John Doe 2 to do this so he could see "anal wink." Elizabeth stated Mr. Cordum then asked for a cotton square or Q-Tip to touch his rectum to see the reactivity of the rectum.

Elizabeth stated Mr. Cordum proceeded to brush John Doe 2's inner thigh while stating that when you brush a man's thigh, his testicles and scrotum move. Elizabeth stated alarm bells were going off in her head, and she told Mr. Cordum, John Doe 2 seems like he is done. Elizabeth stated John Doe 2 got dressed, and Mr. Cordum indicated he would write a report, and develop a plan with the pediatrician.

Elizabeth did stated Mr. Cordum never put on gloves and handled John Doe 2 bare handed for the entirety of the visit.

Elizabeth stated while in the living room, before Cordum left, John Doe 2 mentioned he liked Mr. Cordum's

car which was parked in front of the house. Mr. Cordum responded that he was waiting for his John Doe 2's acceptance. Elizabeth stated she felt those comments were off putting and felt uncomfortable.

Elizabeth stated she called the pediatrician's office following the visit. She was met with silence when mentioning Jared. Elizabeth stated the pediatrician then mentioned Mr. Cordum is under investigation for questionable practices, apologized, and then stated he recommends John Doe 2 see a child psychologist.

Elizabeth stated Jared attempted to set up a follow up appointment, and she declined further services.

Elizabeth stated Mr. Cordum had numerous electronic devices during the visit that he utilized like an I-Pad and laptop. This concluded the interview.

On June 25, 2024, I conducted a telephone interview with John Doe 2's father, Ryan [REDACTED]. Ryan stated he found out about the occupational therapist services from an employee, Alex LNU, through the day care center John Doe 2 utilizes, the Child Development Center on Cannon Airforce Base (CAFB). Ryan stated John Doe 2 was having issues with potty training and needed to be admitted for this recently. Ryan stated one of the directors recommended Outside the Box Therapy, and stated their insurance would cover their services. Ryan stated he then contacted his pediatrician on CAFB, Dr. Schoof, and obtained a referral, and was subsequently approved through his insurance.

Ryan stated contact with Mr. Cordum was not in his control as they are divorced, and John Doe 2's mother was coordinating everything. Ryan stated the appointment was scheduled, and occurred at Elizabeth's house, but he did not know the date or time of the appointment, so he did not attend.

Ryan stated he checked on June 25, 2024, and found out Jared Cordum or his affiliated business has not billed his insurance for the appointment that occurred on April 24, 2024. Ryan stated he found this odd because everything he (Cordum) did, was not billed, nor was there any documentation provided as if the visit didn't happen. This concluded the interview.

On June 18, 2024, Jacob A. Schoof, the Pediatric Medical Director and pediatrician at CAFB wrote an email to Special Agent Balcita with the Air Force Office of Special Investigations that stated the following:

"Good afternoon, sir,

I was personally involved in both cases as the referring provider for occupational therapy.

[REDACTED] - Reviewed notes were my documentation indicating referral request by mother for Outside the Box as they could provide services in home, and mother specifically requesting a male provider.

Patient was referred for help with regulating emotions and emotional outbursts at school.

NO documentation for occupational therapist available for review, but the reported exercise on police report of having patient take a bubble bath and specifically requesting patient to clean self without swimsuit does NOT go in line with what I would expect to be done based on the nature of the referral.

[REDACTED] - I again was personally involved in this case and was the referring provider to occupational therapy to help with difficulty potty training in the setting of severe constipation.

NO notes or documentation available to review from the occupational therapist.

Based on what was reported to me by mother, and what was documented in the police report, activities done by therapist did not align with what I would expect to be done based on the nature of the referral

On June 25, 2024, I conducted a telephonic interview with Amanda [REDACTED], mother of her ten-year-old boy, John Doe 3. Amanda stated around September 2022, John Doe 3 had issues at school. Amanda stated John Doe 3's teacher reached out to her about John Doe 3's reading and math scores and overall impulse control. Amanda stated she went to her pediatrician, Dr. Kristen Jeffcoat. Amanda stated she was at a crossroad between medication, or strategies, and she wanted to avoid the medication if it could be solved otherwise.

Amanda stated after some appointments, John Doe 3 was diagnosed with attention deficit hyperactivity disorder (ADHD) and Oppositional Defiant Disorder (ODD). Amanda stated following more tests, a referral was given to Outside the Box Therapy with Mr. Cordum. Amanda stated she had a conversation with Mr. Cordum was March 22, 2023. Amanda stated on March 29, 2023, Mr. Cordum met them at their house located at [REDACTED]. Amanda stated she could not stay for that meeting due to work, but her husband, Aaron [REDACTED] was present for this meeting. Amanda stated Mr. Cordum called later that night, and she explained what her issues with John Doe 3 were, mainly the ADHD and ODD. Amanda stated she was looking for a counselor, not an occupational therapist.

Amanda stated in the month of December 2023, John Doe 3 was still exhibiting the behaviors that were concerning. Amanda stated John Doe 3 was hitting holes in walls, and she was having difficulties affording the counseling. Amanda stated she went back to Dr. Jeffcoat, who again recommended Mr. Cordum's service.

Amanda stated December 18, 2023, Mr. Cordum came to her house for an appointment. Amanda stated Jared went into John Doe 3's room and observed the holes in the wall. Amanda stated as they were concluding the conversation, Jared started a conversation about bedwetting, constipation, or anything else in that nature. Amanda stated she did disclose John Doe 3 was potty trained but had recently started wetting the bed. Amanda stated Mr. Cordum then talked about being certified in bed wetting. Amanda stated Mr. Cordum then advised he could run to his house and get an ultrasound machine. Amanda questioned why he needed this device, and Mr. Cordum stated kids who are constipated can sometimes wet the bed. Amanda stated she thought kids with ADHD were more prone to bedwetting due to the activity in their brain, but Mr. Cordum insisted on the constipation. Amanda stated Mr. Cordum left and returned to her house with an ultrasounds machine.

Amanda stated when Mr. Cordum returned, he had John Doe 3 lay down in the living room and put a towel down below John Doe 3's belt/bladder area. He then utilized the ultrasound machine. Amanda stated there were red flags going off in her head, and she remembered Mr. Cordum was not utilizing gloves. Amanda stated when she was pregnant, the medical professional used gloves when getting ultrasounds. Amanda stated Mr. Cordum was stating John Doe 3 had a lot of poop and was showing her on the screen. Amanda stated she found that off because she had x-rays, and ultrasounds performed on John Doe 3, and everything was normal including his bladder, kidneys, and constipation. Amanda stated Mr. Cordum then requested an x-ray be

performed on John Doe 3.

Amanda stated they got an x-ray completed, and on the 21st of December, Mr. Cordum stated he would come back and give the result of the x-ray. Amanda stated she again had to work and was not present for the appointment. Amanda stated when she got home; John Doe 3 met her by the door crying. Amanda stated John Doe 3 was saying he needed to talk to her and wanted to go to his room to sit down and talk. Amanda described this to be out of character for John Doe 3, as he is usually off the wall, hyper, and not a crier. Amanda stated John Doe 3 told her Mr. Cordum came over and did not have the x-ray. John Doe 3 said Mr. Cordum told him he needed to get undressed. John Doe 3 stated Mr. Cordum said he needed to do an exam which evaluates the muscles' ability to go to the restroom.

Amanda stated she always taught John Doe 3 to not undress anywhere other than their bedrooms for privacy. John Doe 3 stated Mr. Cordum requested John Doe 3 get undressed in the living room, and he felt uncomfortable and tried to say no. John Doe 3 said he asked to go to the bedroom, and they went to the restroom. John Doe 3 stated Mr. Cordum asked him to get nude from the waist down, and to lay on the ground. John Doe 3 stated when on the ground, Mr. Cordum put electrode stickers on his arm/bicep area. John Doe 3 said Mr. Cordum explained how it worked and proceeded to put electrodes on both sides of John Doe 3's inner thigh. It was explained when Mr. Cordum applied these electrode stickers, he moved John Doe 3's penis and testicles around with his bare hands. Two more electrode stickers were placed on John Doe 3's buttocks near his anus by Mr. Cordum and he again touched his penis and testicles while doing this. Amanda said John Doe 3 told her he was uncomfortable, tried saying no, and that he did not like it, but his father who was present tried to say it was okay due to him being a medical professional.

Amanda stated during the visits, Mr. Cordum had an I-Pad/tablet with him which was next to the machine he used. Amanda stated the tablet was also set up next to John Doe 3 when the electrode stickers were being utilized.

Amanda stated she called Mr. Cordum later that night and asked for an explanation since he never explained this would be part of the treatment, and the focus was supposed to be ADHD, and ODD strategies. Amanda stated Mr. Cordum explained biofeedback and was gathering information to help. Amanda stated she did not want to be helped and told Mr. Cordum he would cease services.

Amanda stated she contacted another Occupational Therapist, Melony Thomas, on December 22, 2023, asking for advice. Amanda stated she explained the treatment John Doe 3 received, and asked if this was a normal practice. Amanda stated Melony told her the only time biofeedback was utilized was in elderly women. Amanda stated Melony said the probes would never go near the genitalia and were only to be placed on the bladder to stimulate the bladder to assist urination. Amanda stated Melony said she never seen this practice on men or boys, and never below the belt.

Amanda mentioned she was fearful of retaliation from Mr. Cordum because of their last conversation on the phone on the 21st of December, Mr. Cordum said he was going to reach out to mental health resources. Mr. Cordum said he wanted to do this because John Doe 3 did not want to get undressed, and claimed he thinks Amanda's foster son is sexually assaulting her son. Amanda asked for evidence on what made him think that, and Mr. Cordum stated that John Doe 3 wouldn't get naked in front of her foster son which led him to think that. Amanda stated her children talk to her and would tell her if anything of that nature was occurring. Amanda stated she felt Mr. Cordum accused her foster son of this to put the blame on someone else in the event she reported this. Amanda also felt this was a threat to involve CYFD and create a big investigation if she reported Mr. Cordum. I did not locate any reports from Mr. Cordum regarding his concern for sexual

abuse from one child to another in Amanda [REDACTED] household.

Amanda stated it took months for John Doe 3 to feel comfortable going to the doctor office following Mr. Cordum's appointment. Amanda stated the problematic behaviors have increased. This concluded the interview.

On July 26, 2024, I conducted a telephonic interview with John Doe 3's father, Aaron [REDACTED]. Aaron stated he made an appointment with John Doe 3's primary care physician, Dr. Jeffcoat at Dynamic Healthcare in Clovis, NM. Aaron stated the reason for visits was for John Doe 3's ADHD and other general thing at which time they were referred to Outside the Box Therapy, where they met Mr. Cordum.

Aaron stated appointments were set up with Mr. Cordum, and an initial conversation and evaluation was done. Aaron stated bedwetting was brought up, and Mr. Cordum mentioned he was specialized in bedwetting and its treatment. Aaron stated Mr. Cordum started gearing more towards the bedwetting rather than focusing on ADHD and the initial concerns they had. Aaron stated John Doe 3 was referred for an x-ray, and there was a follow up appointment with Mr. Cordum.

Aaron stated in the month of December 2023, Mr. Cordum brought a diagnostic tool to run a test on John Doe 3. Aaron stated he, John Doe 3 and Mr. Cordum were in the living room of their home located at [REDACTED]. Aaron said Mr. Cordum brought a new diagnostic tool he wanted to try to use, and asked John Doe 3 if he would be more comfortable in a private room. Aaron stated John Doe 3, himself, and Mr. Cordum relocated to John Doe 3's bedroom. Aaron said John Doe 3 was asked to pull down his pants, and John Doe 3 did not want to because he was uncomfortable. Aaron stated he explained to John Doe 3 that sometimes during appointments this must happen for medical professionals to do their work. Aaron stated John Doe 3 did pull his pants down and proceeded to sit on the floor while Mr. Cordum explained the diagnostic tool.

Aaron stated Mr. Cordum instructed John Doe 3 to lay on his back and hold his legs up while he put the electrode stickers on his buttocks near his butthole. Aaron stated after placing the stickers on John Doe 3, Mr. Cordum connected it to the lead device, and instructed John Doe 3 to push, hold, and other things for approximately ten to fifteen Ninths at a time numerous times. Aaron stated he then removed the electrode stickers, showed him the diagnostics, and went over the x-rays. Aaron stated Mr. Cordum then attempted to set up another appointment to discuss the results of this one, but after talking to his wife they decided to terminate the services with Mr. Cordum due to feeling uncomfortable.

Aaron stated when Mr. Cordum was putting the electrode stickers on John Doe 3's buttocks near his anus, he was not wearing gloves. Aaron stated he also was moving John Doe 3's testicles around so he could put the electrode stickers.

Aaron mentioned he noticed an increase in frequency of the outbursts and anger in John Doe 3 following his appointment with Mr. Cordum

Aaron stated there was a laptop or tablet with a keyboard that was open while Mr. Cordum was getting the diagnostics. Aaron stated Mr. Cordum always takes notes and on the electronic device. Aaron mentioned Mr. Cordum also had a small ultrasound machine.

Aaron recalled he was supposed to go over the x-rays of John Doe 3 but does not recall ever being shown them or talking about them with Mr. Cordum.

On June 27, 2024, I received a phone call from Sara [REDACTED], who stated in March 2023, during one of the appointments with her son, (John Doe 4), Mr. Cordum, took his cell phone, and propped it up on his sons desk. Sara stated Mr. Cordum stated he was using the cell phone for a timer, but she felt uncomfortable since it was propped up facing John Doe 4 for the visit. Sara stated John Doe 4 was naked during the visit. Sara stated the front was facing Mr. Cordum and John Doe 4. Sara stated she thought Mr. Cordum was recording her nude son who is seven years of age.

On June 10, 2024, Joseph Muniak, with The Experts Robson Forensic, was provided with the Clovis Police Department Incident #24-00743, Roosevelt County Sheriff's Office - Benjamin Rice #608 - Supplemental Report, Lindsey Elementary School - Tawna Speer, LPCC Report, Valencia Elementary School - Brooke Bowman and Ofelia Alvarez Report, Valencia Elementary School - Jim Collins Report, Valencia Elementary School - Brooke Bowman Report, Horonato Supplement Report - Incident 24-00743 Report, Jared Cordum - Board of Examiners for Occupational Therapy - online licensure verification, 1-12A-4. Occupational Therapy Services description, Title 16, Chapter 15, Part 3 - Occupational and Professional Licensing - New Mexico, State of New Mexico, Youth and Families Department - CPS Intake Report = Report # 1993477, State of New Mexico Children, Youth and Families Department - CPS Report - Report # 1998806, Air Force Office of Special Investigations - Report of Investigative Activity - Report# 35996241551560051, Air Force Office of Special Investigations - Report of Investigative Activity - Report# 359962415517160012, and Air Force Office of Special Investigations - Report of Investigative Activity - Report# 359962415516290057.

Joseph Muniak stated he analyzed the aforementioned documents related to treatments provided to minor children by Mr. Cordum.

Joseph Muniak stated, "Within the bounds of reasonable professional certainty and subject to change if additional information becomes available, it is my professional opinion that:

1. Jared Cordum violated the standard of care for occupational therapy treatment when he chose to administer medications (enemas and suppositories) to his patients.

Medication administration is not supported by the Occupational Therapy Profession - Scope of Practice Definitions for New Mexico

2. Jared Cordum violated the standard of care for occupational therapy when he intentionally extended his treatment to include siblings of patients, who were not under his direct treatment, in bathing and dressing tasks.

These actions are a violation of several Core Values and Principles listed in the American Occupational Therapy Association (AOTA)

3. Jared Cordum violated the standard of care for occupational therapy when he failed to implement interventions what would address patient's specific needs and deficits in a safe and appropriate manner."

- "4. Jared Cordum intentionally violated the standard of care for occupational therapy when he directed children to remove their swim trunks during bathing/showering routines, despite parents/guardian expressed desire to the contrary, and no stated therapeutic goal for these actions.

These actions are a violation of several Core Values and Principles listed in the American Occupational Therapy Association (AOTA)"

"5. Jared Cordum violated the standard of care for occupational therapy treatment when he utilized imaging modalities to diagnose a bowel issue with his patient.

Use of 'ultrasound,' or sonographic imaging for diagnostic purposes is not supported by the Occupational Therapy Profession - Scope of Practice Definitions for New Mexico. This practice is also requiring licensure in the state of New Mexico.

On multiple occasions, Mr. Cordum practiced medicine by conducting procedures outside of the scope of his certifications for appointments with John Doe 1, John Doe 2, and John Doe 3. In these appointments with Mr. Cordum, Mr. Cordum touched the minors John Doe 1, John Doe 2, and John Doe 3's genitals bare handed outside of the scope of his role as an occupational therapist. Mr. Cordum also penetrated John Doe 1 using an enema outside the scope of his role as an occupational therapist and instruction of Medical Doctors.

Your Declarant knows that the arrest warrant for Jared Cordum, once entered into law enforcement databases, will be available to law enforcement officers across New Mexico. Your Declarant cannot reasonably predict where Jared Cordum may be contacted or what time during the day or night when that contact and arrest will occur. As such, your Declarant requests that Night Service be authorized allowing the arrest warrant to be active at anytime allowing officers to facilitate the arrest and service of the arrest warrant.

**REQUEST**

Based on the aforementioned facts, I respectfully request a warrant be issued, upon probable cause, for the arrest of Jared Cordum.
