**NOTICE IS HEREBY** given that a Hybrid Public Hearing will be held before the City of Homestead City Council (the "City Council") on **Wednesday, March 18, 2026**, immediately following the Council Presentation Ceremony at 5:00 p.m. in the City Hall Council Chambers located at 100 Civic Court, Homestead, Florida, 33030. The following item(s) will be heard:

The City of Homestead proposes to adopt the following ordinances:

**AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY CODE OF ORDINANCES BY AMENDING CHAPTER 30 "ZONING," ARTICLE IV, "SUPPLEMENTAL DISTRICT REGULATIONS," DIVISION I, "GENERALLY," TO CREATE SECTION 30-405.2, ENTITLED "FRONTAGE DEFINITION FOR ADDRESSING PURPOSES," ESTABLISHING STANDARDS FOR DETERMINING OFFICIAL PROPERTY ADDRESSING FOR INTERIOR LOTS, CORNER LOTS, VACANT PARCELS, COMMERCIAL AND MIXED-USE PROPERTIES, AND DOUBLE-FRONTAGE LOTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY CODE OF ORDINANCES BY AMENDING CHAPTER 16 "LOCAL BUSINESS TAXES AND BUSINESS REGULATIONS," ARTICLE II, "LOCAL BUSINESS TAX RECEIPTS," SECTION 16-40, "SCHEDULE OF LOCAL BUSINESS TAXES," BY ADOPTING THE NORTH AMERICAN INDUSTRY CLASSIFICATION SYSTEM (NAICS) MANUAL TO REPLACE THE STANDARD INDUSTRIAL CLASSIFICATION (SIC) SYSTEM AS THE STANDARD BY WHICH ALL BUSINESSES, OCCUPATIONS, AND PROFESSIONS SUBJECT TO A LOCAL BUSINESS TAX SHALL BE CLASSIFIED; REPEALING AND REPLACING RELATED PROVISIONS TO REFLECT THE ADOPTION OF THE NAICS MANUAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

In addition, the City will be accepting written public comments as part of the Hybrid Public Hearing, which can be emailed to [publiccomments@cityofhomestead.com](mailto:publiccomments@cityofhomestead.com). Written public comments on specific agenda items (including your name, address, item you would like to comment on, and your comment) can be submitted up until noon on Tuesday, March 17, 2026, and reviewed by the Council as part of the record. All written public comments are limited to 300 words per comment.

If a person decides to appeal any decision made by the City Council with respect to any matter considered at a meeting or hearing, that person will need a record of the proceedings and, for such purpose, may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.
