NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY given that a Hybrid Public Hearing will be held before the City of Homestead City Council (the “City Council”) on **Wednesday, January 21, 2026**, immediately following the Council Presentation Ceremony at 5:00 p.m. in the City Hall Council Chambers located at 100 Civic Court, Homestead, Florida, 33030. The following item(s) will be heard:

A RESOLUTION OF THE CITY OF HOMESTEAD, FLORIDA, APPROVING AN AMENDMENT TO A PREVIOUSLY APPROVED SITE PLAN, AS REQUESTED BY KEYS GATE III TRUST, FOR THE DEVELOPMENT OF A 1,287 DWELLING UNIT RESIDENTIAL SUBDIVISION ON AN APPROXIMATELY 206.0 ACRE PARCEL OF LAND LOCATED WITHIN THE VILLAGES OF HOMESTEAD DEVELOPMENT OF REGIONAL IMPACT (VOH-DRI), GENERALLY LOCATED SOUTH OF SOUTH CANAL DRIVE AND NORTH OF SW 352ND STREET, AS LEGALLY DESCRIBED IN EXHIBIT “A;” AND PROVIDING FOR AN EFFECTIVE DATE.

A RESOLUTION OF THE CITY OF HOMESTEAD, FLORIDA, APPROVING AN AMENDMENT TO A PREVIOUSLY APPROVED SITE PLAN, AS REQUESTED BY KEYS GATE III TRUST, FOR THE DEVELOPMENT OF A FIFTY-ONE (51) DWELLING UNIT SINGLE FAMILY RESIDENTIAL SUBDIVISION ON AN APPROXIMATELY 10.0 ACRE PARCEL OF LAND LOCATED WITHIN THE VILLAGES OF HOMESTEAD DEVELOPMENT OF REGIONAL IMPACT (VOH-DRI), GENERALLY LOCATED SOUTH OF SW 328TH STREET AND WEST OF SW 152ND AVENUE, AS LEGALLY DESCRIBED IN EXHIBIT “A;” AND PROVIDING FOR AN EFFECTIVE DATE.

A RESOLUTION OF THE CITY OF HOMESTEAD, FLORIDA, GRANTING SITE PLAN APPROVAL, AS REQUESTED BY NEW HEALTH COMMUNITY CENTERS, INC., FOR THE DEVELOPMENT OF A MEDICAL OFFICE LOCATED ON AN APPROXIMATELY 0.299 ACRE PARCEL OF LAND, GENERALLY LOCATED AT 100 NW 7 STREET, AS LEGALLY DESCRIBED IN EXHIBIT "A;" AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, APPROVING THE REZONING, AS REQUESTED BY NEW HEALTH COMMUNITY CENTERS, INC., OF AN APPROXIMATELY 0.299 ACRE PARCEL OF LAND FROM MULTIPLE APARTMENT (R-3) ZONING DISTRICT TO RESTRICTED RETAIL COMMERCIAL (B-1) ZONING DISTRICT FOR PROPERTY LOCATED AT 100 NW 7TH STREET, AS LEGALLY DESCRIBED IN EXHIBIT “A;” PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY CODE OF ORDINANCES BY AMENDING CHAPTER 30 “ZONING,” ARTICLE I “IN GENERAL,” SECTION 30-1 “DEFINITIONS” PROVIDING FOR DEFINITIONS RELATED TO ACCESSORY DWELLING UNITS; AND FURTHER AMENDING ARTICLE IV “SUPPLEMENTAL DISTRICT REGULATIONS” TO ESTABLISH REGULATIONS AND STANDARDS FOR ACCESSORY DWELLING UNITS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

In addition, the City will be accepting written public comments as part of the Hybrid Public Hearing, which can be emailed to publiccomments@cityofhomestead.com. Written public comments on specific agenda items (including your name, address, item you would like to comment on, and your comment) can be submitted up until noon on Tuesday, January 20, 2026, and reviewed by the Council as part of the record. All written public comments are limited to 300 words per comment.

If a person decides to appeal any decision made by the City Council with respect to any matter considered at a meeting or hearing, that person will need a record of the proceedings and, for such purpose, may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.
