NOTICE IS HEREBY given that a Hybrid Public Hearing will be held before the City of Homestead City Council (the "City Council") on **Wednesday, July 22, 2026**, immediately following the Council Presentation Ceremony at 5:00 p.m. in the City Hall Council Chambers located at 100 Civic Court, Homestead, Florida, 33030. The following item(s) will be heard:

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY CODE OF ORDINANCES BY AMENDING CHAPTER 30, "ZONING," ARTICLE I, "IN GENERAL," SECTION 30-1, "DEFINITIONS," TO CREATE DEFINITIONS RELATING TO SMALL ANIMAL CLINICS; AND AMENDING CHAPTER 30, "ZONING," ARTICLE III, "DISTRICT REGULATIONS," DIVISION 10, "B-1A PROFESSIONAL BUSINESS RESTRICTED DISTRICT," SECTION 30-241, "USES PERMITTED," AND DIVISION 11, "B-1 RESTRICTED RETAIL COMMERCIAL DISTRICT," SECTION 30-256, "USES PERMITTED," TO ALLOW SMALL ANIMAL CLINICS AS A PERMITTED USE IN B-1A AND B-1 ZONING DISTRICT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY CODE OF ORDINANCES BY AMENDING CHAPTER 30, "ZONING," ARTICLE I, "IN GENERAL," SECTION 30-1, "DEFINITIONS," TO CREATE A DEFINITION FOR EXPRESS MECHANICAL CARWASH; AND AMENDING CHAPTER 30, "ZONING," ARTICLE III, "DISTRICT REGULATIONS," DIVISION 12, "B-2 RETAIL COMMERCIAL DISTRICT," SECTION 30-276, "USES PERMITTED," TO ALLOW EXPRESS MECHANICAL CARWASHES AS A PERMITTED USE IN THE B-2 ZONING DISTRICT; AND AMENDING CHAPTER 30, "ZONING," ARTICLE IV, "SUPPLEMENTAL DISTRICT REGULATIONS," DIVISION 9, "MIXED USE AND NON-RESIDENTIAL DEVELOPMENT STANDARDS," SECTION 30-540, "SERVICE STATIONS, AUTO REPAIR, AND CAR WASHES," TO ESTABLISH DEVELOPMENT STANDARDS FOR EXPRESS MECHANICAL CARWASHES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY CODE OF ORDINANCES BY AMENDING CHAPTER 30, "ZONING," ARTICLE IV, "SUPPLEMENTAL REGULATIONS," DIVISION I, "IN GENERAL," SECTION 30-419, "SIDEWALK CAFÉ AND OPEN-AIR CAFÉ," TO PERMIT OPEN-AIR CAFÉS AS AN ACCESSORY USE TO RESTAURANTS WITHIN THE B-3 ZONING DISTRICT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, APPROVING THE REZONING, AS REQUESTED BY FLIGHTWAY 20, LLC., OF AN APPROXIMATELY 5 ACRE PARCEL OF LAND FROM AGRICULTURAL (AU) ZONING DISTRICT TO LIGHT INDUSTRIAL (I-1) ZONING DISTRICT FOR PROPERTY GENERALLY LOCATED ON THE SOUTHWEST CORNER OF SE 8TH STREET AND SW 147TH AVENUE, AS LEGALLY DESCRIBED IN EXHIBIT "A;" PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

A RESOLUTION OF THE CITY OF HOMESTEAD, FLORIDA, GRANTING FINAL PLAT APPROVAL, AS REQUESTED BY HG PHASE I, LLC., FOR THE REDEVELOPMENT OF 150 EXISTING RENTAL-ASSISTED AND AFFORDABLE HOUSING UNITS AND THE DEVELOPMENT OF 100 NEW RENTAL-ASSISTED AND AFFORDABLE HOUSING UNITS, TOTALING 250 UNITS ON AN APPROXIMATELY 8.744 ACRE PARCEL OF LAND, LOCATED AT 1501 SW 6TH STREET, AS LEGALLY DESCRIBED IN EXHIBIT "A;" AND PROVIDING FOR AN EFFECTIVE DATE.

In addition, the City will be accepting written public comments as part of the Hybrid Public Hearing, which can be emailed to publiccomments@cityofhomestead.com. Written public comments on specific agenda items (including your name, address, item you would like to comment on, and your comment) can be submitted up until noon on Tuesday, July 21, 2026, and reviewed by the Council as part of the record. All written public comments are limited to 300 words per comment.

If a person decides to appeal any decision made by the City Council with respect to any matter considered at a meeting or hearing, that person will need a record of the proceedings and, for such purpose, may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.
