NOTICE OF HYBRID PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City of Homestead (the “City”) will hold a hybrid Public Hearing before the City of Homestead City Council on the below referenced items at a Council meeting on **Tuesday, July 7, at 5:05 p.m. or immediately following previously scheduled meetings in the City Hall Council Chambers located at 100 Civic Court, Homestead, Florida, 33030.**

The City of Homestead proposes to adopt the following ordinances:

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING CHAPTER 19, ARTICLE II OF THE CITY CODE, ENTITLED "NOISE," TO ESTABLISH OBJECTIVE DECIBEL-BASED STANDARDS, PROVIDE STANDARDIZED MEASUREMENT PROCEDURES, AND DEFINE EXEMPTIONS FOR CERTAIN ACTIVITIES; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, ESTABLISHING A TEMPORARY EXTENDED COMPLIANCE PROGRAM FOR CERTAIN EXISTING WINDOW SIGN VIOLATIONS OF SECTION 23-80(5)(d) OF THE CITY CODE; PROVIDING FOR CONTINUED ENFORCEMENT THROUGH THE ISSUANCE OF NOTICES OF VIOLATION; PROVIDING FOR A ONE-YEAR COMPLIANCE PERIOD BEFORE REFERRAL TO THE SPECIAL MAGISTRATE FOR QUALIFYING EXISTING VIOLATIONS; PROVIDING FOR EXCEPTIONS; PROVIDING FOR ADMINISTRATION; PROVIDING THAT THE UNDERLYING CODE REQUIREMENTS REMAIN IN FULL FORCE AND EFFECT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR NONCODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING CHAPTER 7, ARTICLE I, SECTION 7-5 OF THE CITY CODE, ENTITLED "SPECIAL MASTER SYSTEM CREATED; QUALIFICATIONS; TERMS; REMOVAL," TO REVISE THE QUALIFICATIONS AND THE COMPENSATION STRUCTURE FOR SPECIAL MASTERS; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING THE CITY OF HOMESTEAD CODE OF ORDINANCES BY CREATING DIVISION 3, "INTERFAITH ADVISORY BOARD" OF ARTICLE III "BOARDS COMMITTEES, COMMISSIONS" OF CHAPTER 2 "ADMINISTRATION"; PROVIDING FOR PURPOSE AND INTENT; ESTABLISHING POWERS AND DUTIES; PROVIDING FOR CODIFICATION; SEVERABILITY; AND AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HOMESTEAD, FLORIDA, AMENDING CHAPTER 2, "ADMINISTRATION," ARTICLE III, "BOARDS, COMMITTEES, COMMISSIONS," OF THE CITY CODE BY CREATING DIVISION 1.5, "AGRICULTURAL COMMITTEE," TO ESTABLISH THE AGRICULTURAL COMMITTEE AS A STANDING ADVISORY COMMITTEE OF THE CITY; PROVIDING FOR CONFLICTS, SEVERABILITY, CODIFICATION, AND AN EFFECTIVE DATE.

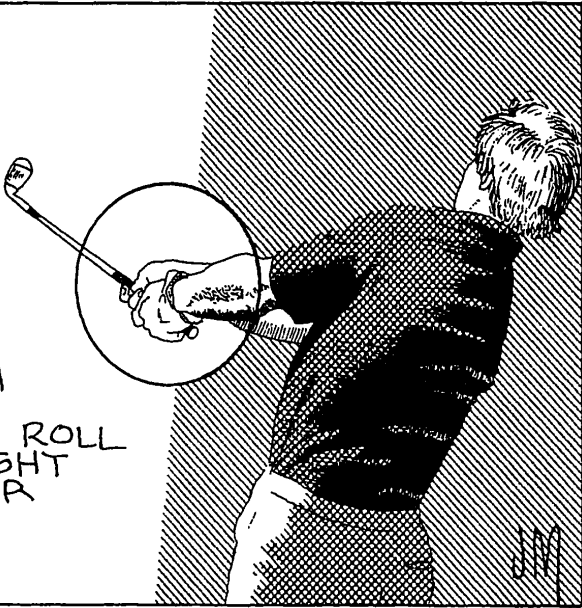

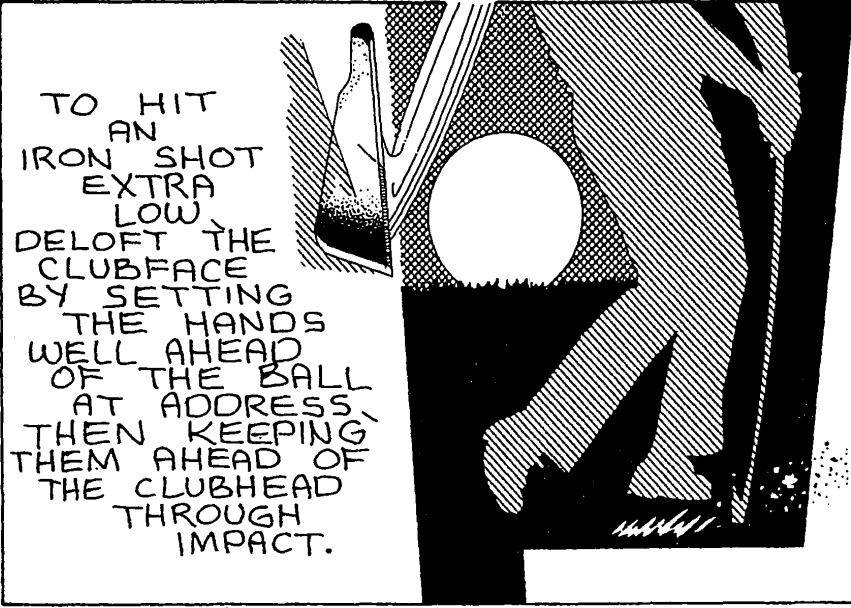

THE KEY TO ACHIEVING MAXIMUM HEIGHT ON AN IRON SHOT IS TO OPEN THE CLUBFACE AT ADDRESS, THEN KEEP IT OPEN THROUGH IMPACT BY DELAYING THE ROLL OF THE RIGHT HAND OVER THE LEFT.



TO HIT AN IRON SHOT EXTRA LOW, DELOFT THE CLUBFACE BY SETTING THE HANDS WELL AHEAD OF THE BALL AT ADDRESS, THEN KEEPING THEM AHEAD OF THE CLUBHEAD THROUGH IMPACT.
