Dear Agent Mueller:

I understand that the officers who executed the Search Warrant had requested the school search for the items referenced in the July 9, 2003 letter to Richard Beems, a copy of which I have enclosed. We have searched our files and have been able to locate the following:

1. the background information regarding DataBank Services, the computer forensics company we retained in 2003;
2. a copy of the report prepared by DataBank Services; and
3. a copy of a CD Rom containing an examination of some of the graphics and file references on Mr. Siebel's computer.

Although I am very confident that the items identified above and enclosed with this letter were in fact three of the four enclosures referenced, I cannot be absolutely certain. I was unable to find a copy of the hard copy print out of the contents of the enclosed CD Rom, as referenced in the July 9, 2003 letter.

My client has asked that I forward to you the documents you requested. For purposes of these documents only, we will treat them as having been gathered pursuant to the Search Warrant. They have been marked as Bates Numbers D 000001 – D 000026.
