COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Aiding and Abetting Theft-Take/Use/Transfer Movable Prop-No Consent

Minnesota Statute: 609.52.2(1), with reference to: 609.05.1, 609.52.3(3)(c)

Maximum Sentence: Not more than 5 years, \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/17/2012 to 06/19/2012

Control #(ICR#): 12000978

Charge Description: On or about June 17, 2012 and June 19, 2012, in Rice County, Defendant Adam Anthony Wunderlich did intentionally aided, advised, hired, counseled, or conspired with or otherwise procured another with the intent to commit a crime, did unlawfully and feloniously, intentionally and without claim of right, take, use, transfer, conceal or retain possession of property of another without the other's consent and with intent to deprive the owner permanently of possession of the property and the value of the property is more than \$500 but not more than \$1000 and the defendant has been convicted within the preceding five years of an offense under this section.

COUNT II

Charge: Aiding and Abetting Theft-Take/Use/Transfer Movable Prop-No Consent

Minnesota Statute: 609.52.2(1), with reference to: 609.05.1, 609.52.3(4)

Maximum Sentence: 1 year and/or \$3,000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 06/11/2012

Control #(ICR#): 12000978

Charge Description: On or about June 17, 2012, and June 19, 2012, in Rice County, Adam Anthony Wunderlich, the defendant, did intentionally aided, advised, hired, counseled, or conspired with or otherwise procured another with the intent to commit a crime, did an act which was a substantial step toward, and more than preparation for the crime of theft, did intentionally and without claim of right taking, using, transferring, concealing or retaining possession of movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property which was of a value more than \$500 but not more than \$1,000.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your Complainant and/or Signing Officer designated below, being duly sworn, has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On June 11, 2012, at about 3:16 p.m., Northfield Police Officer Borchardt was dispatched to National Guard Armory, 519 Division Street South in Northfield, Rice County, on a report of a theft of a wallet. Officer Borchardt arrived at the scene and spoke to the reporting party, MM. MM reported the following:

She was at the gym at about 1:00 p.m. Around 3:15 p.m., she saw a male and female. They wanted to "shoot hoops" in the gym. The female appeared to be startled to find MM there. She told them that the gym was not open. The male and female then left the Armory. MM went to the gym and discovered that her purse was missing. She suspected that the male and female took her purse. MM then provided the officer with descriptions for the male and female.

MM said the value of her purse is about \$70. She said her purse contained an i-phone, i-phone case, a Sony Cybershot camera, \$15 in cash, MN DL, and other personal information, including a bank debit card. The value of the i-phone is \$200. The value of the i-phone case is \$30. The value of the camera is \$350. The total value of the items taken from MM is about \$617.

On June 12, 2012, MM reported that her purse and her debit card and DL and insurance information had been located in a trash can in Northfield. She was informed by a witness that a female had put the purse in the trash can. MM is still missing her i-phone, i-phone case, camera and cash.

Inv. Haider was assigned to conduct follow-up investigation.

Inv. Haider discovered that MM's Sony Cybershot camera had been pawned for \$60 at Pawn American in Burnsville on June 17, 2012. The person who pawned the camera was Adam Wunderlich. He also discovered that on June 19, 2012, Johanna Whipple had pawned the i-phone for \$151.50 at a pawn store in Minneapolis. The i-phone belongs to MM.

On June 21, 2012, Inv. Haider contacted MM. She reviewed a photo line-up. She was able to identify Johanna Whipple as the female she saw at the Northfield Armory on June 11, 2012. She was able to identify Adam Wunderlich as the male she saw at the Northfield Armory on June 11, 2012.

On June 21, 2012, Inv. Haider received the video surveillance for the pawn transactions. Inv. Haider saw Johanna Whipple pawning the i-phone. The video surveillance showed Adam Wunderlich pawning the camera.

On June 26, 2012, Johanna Whipple made the following statements to Sgt. Nelson:

She is in a relationship with Adam Wunderlich for about the past three years. She initially denied knowledge of the thefts. She later admitted to taking the i-phone from the purse. She admitted that she pawned the i-phone and got about \$150. She admitted that she took \$10 in cash from the purse. She threw the i-phone's cover away. She stole the items because she did not have a job and needed money. She admitted that she has a heroin problem. She and Wunderlich were together when when they pawned the items.

On June 26, 2012, Adam Wunderlich admitted his involvement in the thefts to police.

On June 19, 2012, Adam Wunderlich was sentenced for Felony Theft in Rice County District Court File No. 66-CR-12-400. He received a felony sentence.
