# SB 1008

## Significant Changes:

- **437.0126(a)** clarifies that LHDs cannot charge retail permitting fees or other costs that exceed the “maximum” fee charged for the same permit or by DSHS
- **437.0126(a-1)** clarifies that the maximum fee charged by LHDs “annually” may not exceed the maximum fees charged by DSHS “biennially”
- **437.0126(d)(2)** clarifies which counties may assess up to 120% of the DSHS maximum permitting fee under (a)
- **437.030(c)** clarifies that the owner or operator of a workplace to which food is transported or delivered under subsection (b) may not be required to obtain a permit by DSHS or the LHD

1. Initial Inspection -Applicable to New Establishments and conducted to verify compliance with health and safety standards before and establishment begins operations
2. Reinspection is a follow-up visit to confirm that the previously cited violations have been corrected, and the establishment is back to compliance
3. Pursuant to HB 2844, effective July 1, 2026, mobile health permits will be issued under the authority of the Texas Department of State Health Services (DSHS).
4. Amendment - Includes a change of name or ownership of a food establishment

Retail food establishment permit fees

1—4 employees \$ 200.00

5—10 employees \$ 225.00

11—19 employees \$ 250.00

More than 19 employees \$ 300.00

An establishment that files a renewal application after the expiration date must pay an additional fee of \$100

Retail food establishment reinspection fee (if more than 30 demerits or requested by the establishment) \$200

Temporary food establishment: \$52.00 per event or \$200 for one year

Mobile food unit, per unit-\$258.00

Farmers Market permit fees:

A Farmer's Market permit is required to sell all potentially hazardous food that requires time and temperature controls, and does not fall under the exemptions in the Texas Cottage Food Law: \$30.00

Inspections upon request- \$150.00 (Examples include, but are not limited to, Schools and Nursing Homes)
