*I have also contacted Deputy Likens of the Anderson County Sheriffs Office in regards to any background of the suspect while the suspect was a substitute teacher before gaining employment with the Franklin County Board of Education. Deputy Likens stated that the suspect did not have any prior reported criminal incidents or allegations of misconduct while a teacher at that location. The subject only had poor classroom management skills on his evaluation.

* On March 19, 2019 reporting officer conducted a criminal background check through NCIC and his record was clear of any criminal convictions.

NARRATIVE

Investigation notes:

March 20th

On March 15th, 2019 at approximately 0810 hrs. the reporting officer was notified by police dispatch via landline to return the call of a complainant that Frankfort Police Department had taken the night prior. [REDACTED] She [REDACTED] told her that the teacher (Dr. Smith) had squeezed her [REDACTED] st. I spoke with the FPD officer that had taken the initial night prior and explained that he received the call because it was after hours and that he did a report and a JC-3. Upon collecting the basic facts I had called the school superintendent and asked him to meet me [REDACTED] Middle School because there has been allegation [REDACTED] Mr. Kopp and Ms. Holly Adkins responded and arrived at the school about the same time that I arrived [REDACTED] High School. We met with the principal Ms. Whitney Allison. We began to sit down and Mr. Kopp informed Ms. Allison that the reason we are here is because that I had received word [REDACTED] Ms. Allison replied "Yeah, I heard something about this and had started to look into it". Ms. Allison and Mr. Kopp started to make arrangements to have Dr. Smith relieved of duties and find a substitute to take over his classes. I had left the office to an outside office while Mr. Kopp, Ms. Allison and Holly Adkins met with Dr. Smith and then shortly returned to the office. Dr. Smith left without incident to the officers knowledge.

June 19th, 2019

On June 18th, 2019 I received a grand jury suponea from Asst. Commonwealth of Kentucky Attorneys Office, Zack Becker (See file) to serve the Franklin County Board of Education requesting documentation. I served the suponea to Ms. Holly Adkins and she became adjutated and stated "I read the law and I don't think she (Ms. Allison) broke the law. She has to look into it first to see if they broke the law, I just don't see it". She had the law ear marked in her Kentucky School Laws for Duty To Report and when she finished. I tried to explain to Ms. Adkins that immediately report meant that Ms. Allison had a duty to report an incident and not for her to investigate the allegation that was for law enforcement to investigate.

Ms. Adkins was still very adjutated and stated "I will just shut up before I get in trouble".

I was leaving the from Ms. Adkins office and met the superintendent, Mark Kopp coming up the stairs. He asked me how the investigation (Dr. Smith) was going and I told him that it was being processed for a grand jury hearing but there is going to be some collateral damage. He asked me to come to his office. I explained to Mr. Kopp that I had left a suponea for Ms. Adkins requesting some policy and procedures. I told Mr. Kopp that it was requested by the Commonwealth Attorneys office because there was an issue for "failure to report". Mr. Kopp became angry and said "This is bullshit, now we are going to loose a principal over this and I don't believe the teacher did it! I think he might be weird or strange but this is bullshit!". Mr. Kopp stated "I don't know, I am just probly venting here but she is one of our best principals". I told Mr. Kopp that I have said the same thing about her (Ms. Allison) but you just can't dismiss the fact" Mr. Kopp stated "Well, I am going to go to bat for her and do what it takes!" I told Mr. Kopp that I am not the bad guy here and just doing my job. As we stood up there was a folder on the table and he picked up the folder and said "This is the new SRO contract and I am keeping it the same as last for this year". This was in reference of earlier conversations that I had with Mr. Kopp expressing my concerns of him hiring Jeff Abrams as a SRO supervisor. Mr. Kopp then held up the folder and stated exactly "I am doing you a solid, now I need you do me a solid" as to imply make the Ms. Allison situation go away because I did you a favor for not hiring Jeff Abrams. I told Mr. Kopp "You cant find room in shades of gray, don't know what to tell you. I left the meeting at that point.
