

KYIBRS REPORT: NARRATIVE

COMMONWEALTH OF KENTUCKY

NOPSIS:

Frankfort Fire and EMS were dispatched to the Franklin County Regional Jail in response to an unresponsive male. Jail staff located David Drury unresponsive inside G pod at the jail. After being transported to the Frankfort Regional Medical Center Mr. Drury was pronounced deceased.

INVESTIGATION:

with the Franklin County Regional Jail was notified by inmates inside G pod regarding David Drury being unresponsive. quickly notified command staff at the jail who in turn contacted Frankfort Fire and EMS.

Mr. Drury was transported to the Franklin Regional Hospital where he died due to a suspected overdose. The Franklin County Coroner was contacted. The coroner took possession of Mr. Drury's body and a death investigation was opened into Mr. Drury's death.

Dispatch created a separate event number for the original medical run, the EMS run number is 1262-002922.
