### St. Louis County Mayors' Six-Point Plan Calls for New Crime Legislation

St. Louis County, MO – April 18, 2023 – A group of St. Louis regional Mayors joined together calling for new Missouri legislation addressing rising crime in the region. "Crime is a regional issue, yet we have had no strong regional voice on solutions to reduce crime. Instead, we have had endless debates on defunding the police and the performance or lack thereof of Kim Gardner," said Bridgeton Mayor Terry Briggs. "On the eve of the legislature debating a comprehensive crime bill, we are weighing in as a group focused on several items that we believe will reduce crime in the region."

The group of Mayors calling for legislation includes: Bridgeton Mayor Terry Briggs, Wildwood Mayor Jim Bowlin, Manchester Mayor Mike Clement and Brentwood Mayor David Dimmitt.

"The morale of our police has been damaged. Penalties, probationary terms, etc. are too lenient, allowing criminals to remain on the street and crimes to increase – particularly auto thefts. Juveniles are now committing many serious crimes, with limited risk of significant penalties," said Wildwood Mayor Jim Bowlin. "Prosecutorial resources are in some cases insufficient, and law enforcement resources have been under attack."

We recognize the significant problems in the St. Louis City prosecutor's office. Failure to prosecute criminals in any jurisdiction within this region affects the safety of all our residents. Crime is a regional problem and needs a regional solution.

We ask the legislature to combine the St. Louis City Circuit Attorney's office and County Prosecuting Attorney's office into one regional office. This office would have the resources and staff to administer fair criminal justice, ensure a speedy trial for the accused, and take dangerous criminals off the street.

Illegal fentanyl is now the leading cause of more than half of all overdose deaths in Missouri. It is becoming a greater crisis than crack cocaine was in the 90's and requires immediate attention. "Penalties should be increased for the sale and distribution of fentanyl, one of the leading drugs involved in the deaths of thousands of Missourians. One pound of Fentanyl can deliver a lethal dose killing 250,000 people," Bowlin added.

We ask the legislature to make it a life sentence without parole for illegally selling

fentanyl that results in someone's death, and a mandatory sentence of 25 years for possessing more than one pound.

"We need to crack down on drug dealers. Evidence suggests higher level drug dealers are likely to be illegally armed," stated Mayor Dimmitt.

We ask the legislature to increase penalties for those in possession of a firearm and illegal controlled substances. Mirror the Armed Criminal Action statute (Section 571.015), making it a stand-alone offense for those using or possessing a firearm while
