**FINDINGS, ORDER, JUDGMENT, WARRANT AND COMMITMENT

Therefore, this Court having presented Eugene H. Fahrenkrog, Jr. with oral notice of the act so charged, and this Court having presented Eugene H. Fahrenkrog, Jr. with an opportunity to answer to the criminal contempt, the Court finds beyond a reasonable doubt Eugene H. Fahrenkrog, Jr. is guilty of direct criminal contempt.
