The Circuit Attorney of the City of St. Louis, State of Missouri, upon information and belief, charges that

Count1: U UW - Subsection 11 - Possess Weapon and a Felony Controlled Substance (Class D FELONY) RSMo 571.030 ON 6/23/2015 Time: 5:15 PM Place: 4546 Page Blvd (SCC 31188)

The defendant, in violation of Section 571.030.1(11), RSMo, committed the class D felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or about June 23, 2015 at 5:15 PM, in the City of St. Louis, State of Missouri, the defendant knowingly possessed a .40 caliber semi-automatic handgun, a firearm, while the defendant also knowingly possessed heroin.

Count2: U UW - Subsection 11 - Possess Weapon and a Felony Controlled Substance (Class D FELONY) RSMo 571.030 ON 6/23/2015 Time: Place: 4546 Page Blvd (SCC 31188)

The defendant, in violation of Section 195.211, RSMo, committed the class B felony of possession of a controlled substance with intent to distribute, punishable upon conviction under Section 558.011, RSMo, in that on or about June 23, 2015 at 5:15 PM, in the City of St. Louis, State of Missouri, the defendant, with the intent to distribute, possessed heroin, a controlled substance, knowing of its presence and nature.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Circuit Attorney prays that an arrest warrant be issued as provided by law.

PROBABLE CAUSE STATEMENT

DATE: June 24, 2015

I, Matthew Eaton, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that Natalie Williams, a Black Female DOB: [REDACTED]/81 Age: 34, committed one or more criminal offense(s).

2. The facts supporting this belief are as follows:

I, along with other Detectives, executed a search warrant at 4546 Page Blvd, a single family residence. The defendant, a police officer with the St. Louis Metropolitan Police Department, who was the target of our investigation, was at the residence when we arrived. During our search of the residence, the following items were located and seized: a .40 caliber semi-automatic handgun located in the defendant's bedroom; a .45 caliber semi-automatic handgun located in the defendant's bedroom; a substance that lab analysis determined to be heroin in the closet of the defendant's bedroom; and a bag located in the closet of the defendant's bedroom containing items that, based on my experience and training, I believed were used to package heroin for distribution. Specifically, the bag contained a digital scale, a grinder with residue that lab analysis determined to be heroin, multiple empty capsules, a cutting agent, and a box of plastic sandwich baggies. We also seized over \$10,000 in U.S. currency from the closet in the defendant's bedroom.

RESULTS AND CONCLUSIONS:

The analysis of Item 001-01 revealed the presence of Heroin, a Schedule 1 drug with a gross weight of 9.17 grams +/- 0.02 grams with a coverage probability of 95.45%.

The analysis of Item 001-02 revealed the presence of Heroin, a Schedule 1 drug with a gross weight of 0.07 grams +/- 0.02 grams with a coverage probability of 95.45%.

The analysis of Item 001-03-01 did not reveal any controlled substances.
