**SUPERSEDING INDICTMENT**

The Grand Jurors of the City of St. Louis, State of Missouri, charge that:


**Count I**

The defendant, in violation of Section 571.030, RSMo, committed the class E felony of unlawful use of a weapon, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about June 28, 2020, in the city of St. Louis, State of Missouri, the defendant knowingly exhibited, in the presence of one or more persons an assault rifle, a weapon readily capable of lethal use, in an angry or threatening manner.

**Count III**

The defendant, in violation of Section 575.100, RSMo, committed the class E felony of tampering with physical evidence, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or between June 28, 2020 and July 11, 2020, in the City of St. Louis, State of Missouri, the defendant, acting with Patricia McCloskey, altered a Bryco Arms semi-automatic pistol, with the purpose to impair its verity in the investigation of an Unlawful Use of a Weapon--Subsection 4 that occurred on June 28, 2020 on Portland Place, an official investigation, and thereby impaired and obstructed the prosecution of Patricia McCloskey for the crime of Unlawful Use of a Weapon--Subsection 4, a felony.
