The City Council for the City of Credit River, Scott County, Minnesota, hereby ordains that on the 7th day of June 2021, that the City Council for the Credit River adopted the above Ordinance. Due to the lengthy content of the Ordinance, a brief summary follows:

Section 1. Repealer: Repeals Ordinance 2020-03.

Section 2. Rescind and Replace Section. Section 2-4 of the Credit River Zoning Ordinance is rescinded and replaced by the establishment of a new Planning Commission, identifies the composition and terms of the Planning Commission, provides for the organization of the Planning Commission, identifies the powers of the Planning Commission.

Section 3. Effective date. Identifies the effective date of the Ordinance.

Section 4. Repealer. Repeals all prior ordinances to the extent they are inconsistent with Ordinance.

The Town Board hereby adopts and approves the following as its summary of the Driveway Ordinance being amended, and finds the same to conform to M.S. § 331A.01, Subd. 10:

Public Notice. On the 8 day of July 2021, the Town Board of Spring Lake Township adopted an amendment to Ordinance No. 14-001, the "Driveway Ordinance" of Spring Lake Township. The changes permit two driveways on certain, qualifying residential properties, and more than one field approach on certain, qualifying agricultural properties. These amendments were made in the interests of public safety and planning. Moreover, the Town adopted grammar, syntax and proofreading changes made to the ordinance for purposes of clarity. A printed copy of the Township's ordinances is available for inspection by any person during the clerk's regular office hours at the Spring Lake Township office, Spring Lake Township, MN, or the community library. A copy of the Township's ordinances has also been placed on file with Scott County at the law library.
