bout something & no one was suppose to know by
not even 24 passed & told someone. I knew he couldn't
keep his mouth shut so I ask him over & over again if he
told, he finally confessed he did but turned around
again & lied about how much he told. I told him
not to lie and I'll let it go, he kept the story.

So I ask this person what Duck said
and the only way this person knew what me & Duck
talk about was Duck. Duck gave the whole
story. And I was told when I went out in
the rec. yard he would go right back to the gang
hit and talk about killing anyone to get the whole
o.c. to talk about him.

He played me for a fool and he told me
has 2 kids & his sister was raising them.

Then when I got your letter he
told me not to talk about his kids to you.
I don't think he has 2 kids -

Anyway you are sitting on a gold mine. If you need all info on why I shouldn't been near him or anyone else I can send ^{INFO} your lawyer & talk to your lawyer.

The first inmate killing I warned them about and look what happened. To make a long long story shorter I told the judge, Com. Attorney, Hon. Elkins, Adrian Collins, my lawyers all 7 of them 3 investigators, Dr. Ryan, prison guards, state police, and the only one who tried to get the warning out was Dena Potter of the assoc. press. She put "VA. inmate said only way to stop me is death row" and she put how I will kill again. She put it in every paper in VA. Every major paper in the US. Canada, England, Washington Post, US TODAY, ABC, NBC, MSNBC, FOX, Yahoo news had me the top 1 click in the nation for that day of news.

There is a man named Kevin Johnson who is an inmate here, never killed an inmate, but he stabbed a %o. He can't go outside by himself, any time they come to his door they bring a video camera, for mail, food, etc etc.

Now why is it I made all these threats and I already killed an inmate and every paper in the country new it, why wasn't I under the same treatment?

She contacted me on the first inmate
 killing I did. I just wrote her to let them know
 they need to see me.

Here is what they ^{prison} did wrong to allow
 me to do what I did. Besides letting me out
 with people. ① They never strip search me,
 ② I gave them a list of cell #'s I wanted to go
 at with me. ③ When I step out of my cell
 I was wearing a T-shirt and holding a heavy
 ed long sleeve shirt, first clue is why am I
 bringing a big shirt when its 100° outside &
 second they barely patted me down. ④
 there is a video camera 15 feet from us and about
 below the camera there is a window were the
 guard is suppose to be watching us.

There is tons more to this story -
 then you or an attorney contact me
 bout all this before I change my mind
 n getting you a million dollar sent.

Yes I have your address &
 our daughters address I sent out it was
 part of the plan.

Everyone will be o.k. if I get the death penalty. Since Duck is now gone I don't see any reason I will not get it.

I got to court Aug 31, 2010 if someone from your family want to come + I'll call you to the stand to tell the judge what I did.

You see, the com. attorney can't say what I just did until I go to court for it. But if I tell the judge what I did it opens the door to talk about it.

On my last inmate Killing I told everyone in court if I didn't get the death penalty I would kill again. Do you know ^{AFTER THAT} they were going to throw the case out of court. I made them let me plead guilty to it so they wouldn't throw it out.

They will do the same to Duck case if you don't speak up - I didn't want you as a pen-pal it was just part of the plan to get your address just in case -

You'll be o.k. only if they do the right thing. I seen your photo + your not my type - Blue shirt, blue shorts, I sent it out to be copied - and gave back to Duck - I will give you or your lawyer any bite of true + good info to help your law suit.

If you dont have my help -
it will be an up-hill battle -
I want to get even too. They forced
my hand again and Duck made the
mistake in crossing me. I could of
been a big help to him but he
beck me and alot of other people over -
I hope this letter gets into your
hands. If not your loss -
