Upon arrival, Lt. Fradette observed EMT's providing treatment to a male subject later identified as Young Su Kim. Mr. Kim was unresponsive and displayed visible and apparently severe injuries about his head and face. Mr. Kim was transported to Crossing Rivers Health and subsequently med-flighted to Gunderson/Lutheran Hospital in LaCrosse Wisconsin due to the severity of his injuries.

Fradette also discovered a blaze orange shirt with reflective striping with the word "Railworks" in black lettering on the ground on the north side of the restaurant, near the door that leads directly into the kitchen.

Lt. Fradette states that it was determined, through investigation, that employees of a company entitled "Railworks" were staying at the Microtel Hotel. Lt. Fradette and other officers responded to this hotel that same day and identified the foreman of Railworks, who identified his crew as a Kellen Jeffords, Thomas Wilkins, and Jacob Erwin.

Mr. Jeffords stated that he recalls that two (2) of his co-workers joined him for dinner and drinks. Mr. Jeffords stated that he had no recollection of events after this due to his level of intoxication.

Your Complainant states that Lt. Fradette spoke to Mr. Erwin. Mr. Erwin stated that he and Mr. Wilkins met Mr. Jeffords for dinner and drinks at the Wasabi restaurant the evening prior. Mr. Erwin stated that after dinner, he, Mr. Jeffords, Mr. Wilkins, Mr. Klm, and another male subject went into downtown Prairie du Chien to go to a bar and have some drinks. Mr. Erwin stated that after leaving the bar, they gave Mr. Kim a ride back to Wasabi and dropped him off.

Your Complainant states that many loose coins and parts from a cash register were found in a cornfield behind the Bridgeport Inn. Your Complainant states that the remains of the cash register were found later that same day along a road in the general area of the Microtel.

Your Complainant states that Lt. Fradette has attempted to keep in contact with Mr. Kim, however due to his injuries and medical condition, Mr. Kim is unable to communicate. Your Complainant states that he was able to secure a portion of the medical records for Mr. Kim from Gunderson Health System. Your Complainant states that he, as well as Lt. Fradette, have relied on these medical records in the past and have found them to be reliable.

Your Complainant states that among the injuries sustained by Mr. Kim were an intracranial bleed, including a subdural hematoma; subarachnoid hemorrhages more prominent in the right cerebral hemisphere of the brain; and fractures about the nose and face. Your Complainant notes that the records indicate: "Critical care was required due to acute hypoxic respiratory failure". One of the lungs lobes was completely collapsed. Your Complainant states that Mr. Kim remains hospitalized.

Based on the foregoing, the complainant believes this complaint to be true and correct.
