- Sewerage by continuation of services through East Baton Rouge consolidated sewer district.
- Emergency Medical Services though continuation of services provided by the East Baton Rouge Parish Department of EMS.
- 911 services through continuation of services provided by the East Baton Rouge Parish 911 District.
- The City of St, George may provide the following services through contractor(s) or municipal staff:
- Regulation of property use by adoption of planning and zoning ordinance.
- 6.c. Traffic signs and signals.
- 6.d. Maintenance and improvement of municipal public streets and roads
- Maintenance of right of ways.
- Maintenance and improvements to drainage system.
- Regulation of alcohol beverages as authorized by Louisiana Law.
