PETITION OBJECTING TO CANDIDACY OF RICHARD J. BOUDREAUX
AND RULE TO SHOW CAUSE WHY HE SHOULD NOT BE DISQUALIFIED AS
A CANDIDATE FOR CHIEF OF POLICE, CITY OF YOUNGSVILLE

The Petition of DONALD D. LANDRY, District Attorney for the Fifteenth Judicial District of the State of Louisiana, appearing herein by and through the undersigned Assistant District Attorneys, respectfully represents to this Honorable Court the following:

1.

Made Defendants herein are the following persons:

- a) RICHARD J. BOUDREAUX, a candidate for Chief of Police, City of Youngsville, Louisiana;
- b) LOUIS J. PERRET, in his official capacity as the Clerk of Court in and for Lafayette Parish, Louisiana; and
- c) NANCY LANDRY, in her capacity as the Secretary of State in and for the State of Louisiana.

2.

Petitioner has been presented with evidence by one or more registered voters of the City of Youngsville, Louisiana, that Defendant RICHARD J. BOUDREAUX (hereinafter sometimes referred to as "BOUDREAUX"), has illegally qualified as a candidate for Chief of Police, City of Youngsville, Louisiana (hereinafter sometimes referred to as "Chief of Youngsville"). Grayson Linn Bolgiano, Jr., upon information and belief a registered voter, registered in Precinct 116, City of Youngsville, Parish of Lafayette, presented evidence to the Office of the District Attorney, 15th Judicial District, Lafayette, Louisiana, that Defendant BOUDREAUX illegally qualified for elective office by qualifying to run for Chief of Police of Youngsville in the November 5, 2024 special election called to fill the vacancy created by his resignation or retirement on August 21, 2023. The Office of the District Attorney, 15th Judicial District has investigated that evidence and determined that grounds exist for objecting to such candidacy.

3.

In accordance with the provisions of LAS – R.S. 18:491 and 495, Petitioner has determined that sufficient evidence exists for objecting to the candidacy of BOUDREAUX for Chief of Youngsville, and thus brings this action pursuant to the provisions of LSA – R.S. 18:491, et seq., LSA – R.S. 18:1401, et seq. and any other provisions of Louisiana law relating to candidate qualifications, objections to candidacy and conduct of elections.

In accordance with the provisions of LSA – R.S. 18:492, this proceeding objecting to the candidacy of BOUDREAUX for Chief of Youngsville, is based upon the following grounds:

- a) BOUDREAUX does not meet the qualifications of the office he seeks in the Congressional election scheduled for November 5, 2024; and
- b) BOUDREAUX is prohibited by law from becoming a candidate for the office for which he qualified.

5.

In accordance with the provisions of LSA - R.S. 18:1403, the district courts of this state have exclusive original jurisdiction of actions objecting to candidacy.

6.

Pursuant to the provisions of LSA - R.S. 18:1404, this district court is the proper venue for this proceeding as the City of Youngsville, Louisiana, is situated within Lafayette Parish.

7.

LSA – R.S. 18:493 and 1402 require that an "action objecting to candidacy shall be commenced in a court of competent jurisdiction within seven (7) days after the close of qualifications for candidates in the primary election."

8.

This proceeding was timely filed as the date for the close of qualifications for candidates in the primary election of November 5, 2024 was Friday, July 19, 2024.

9.

LSA – R.S. 18:1409 requires that this proceeding "be tried summarily, without a jury, and in open court ... no later than 10:00 a.m., on the fourth day after the suit was filed."

10.

LSA – R.S. 18:1413 provides that the computation of all time intervals with respect to this proceeding shall include Sundays and other legal holidays, except when such time intervals end on a Sunday or other legal holiday, in which case noon of the next legal day shall be deemed to be the end of the time interval.

11.

The City of Youngsville, Louisiana is a "Lawrason Act" municipality governed by the provisions of La. R.S. 33:321, et seq.

12.

La. R.S. 33:385.1 provides that the "an elected chief of police of a municipality shall be an elector of the municipality."

13.

LSA – R.S. 18:451 provides that:

"A person who meets the qualifications for the office he seeks may become a candidate and be voted on in a primary or general election if he qualifies as a candidate in the election. Except as otherwise provided by law, a candidate shall possess the qualifications for the office he seeks at the time he qualifies for that office. In the event that the qualifications for an office include a residency or domicile requirement, a candidate shall meet the established length of residency or domicile as of the date of qualifying, notwithstanding any other provision of law to the contrary. No person, whether or not currently registered as a voter with the registrar of voters, shall become a candidate if he is under an order of imprisonment for conviction of a felony."

14.

La.R.S. 18:586 provides that:

"B. No elected official who has retired or resigned from state or local elective office shall be eligible as a candidate at an election called to fill the vacancy created by the retirement or resignation of the elected official."

15.

On July 17, 2024, BOUDREAUX purportedly qualified as a candidate for Chief of Police, Youngsville, Louisiana, alleging that he had read the Notice of Candidacy and met the qualifications of the office for which he was qualifying. (See Notice of Candidacy Qualifying Form, attached as Exhibit "A".)

16.

BOUDREAUX is not qualified to be a candidate for the office of Chief of Police of Youngsville, Louisiana, for the non-exclusive reasons that he resigned as Chief of Police of Youngsville, Louisiana in August of 2023, creating the vacancy that will be filled at the special election on November 5, 2024. The Secretary of State received the resignation on August 21, 2023, at which time the resignation became irrevocable, as per La.R.S. 18:654. (See certified copy of Retirement / Resignation of Chief Richard J. Boudreaux, dated August 9, 2023 and effective August 21, 2023, attached as Exhibit "B".)

16.

The City of Youngsville received correspondence from the Secretary of State on August 21, 2023 (See certified copy of Letter received by the City of Youngsville from the Secretary of State, attached as Exhibit "D"), which included a copy of the resignation / retirement of BOUDREAUX received that day by the Secretary of State, and after a special meeting the City of Youngsville issued a proclamation calling a special election to fill the position of Chief of Police of Youngsville, Louisiana for November 5, 2024. (See certified copy of Proclamation of City of Youngsville, attached as Exhibit "C".)

17.

Upon information and belief, BOUDREAUX does not meet the qualifications for a candidate for the office of Chief of Police of the City of Youngsville for the special election on November 5, 2024, as he resigned as Chief of Police of the City of Youngsville in August of 2023, creating the vacancy that will be filled by this special election on November 5, 2024.

18.

BOUDREAUX executed the Notice of Candidacy Form on July 17, 2024 (a certified copy of which is attached hereto as Exhibit "A"), wherein he certified that he was a qualified elector of and met the qualifications of the office of as Chief of Police of the City of Youngsville.

19.

Petitioner is informed, believes and therefore alleges that despite the certification contained in the Notice of Candidacy Form referred to above, BOUDREAUX knew, or should have known that he did not meet the necessary qualifications for the office of Chief of Police of the City of Youngsville, on July 17, 2024, the date of qualifying for the following, non-exclusive reasons:

- a) BOUDREAUX resigned as Chief of Police of the City of Youngsville, Louisiana, in August 2023.
- b) BOUDREAUX contacted the Clerk of Court of Lafayette Parish preceding July 17, 2024, the initial date of qualifying to run for the office of Chief of Police of the City of Youngsville, Louisiana.
- c) BOUDREAUX cited the applicable law (La.R.S. 18:586) and indicated to the Clerk of Court that he was aware of the law.
- d) BOUDREAUX is not eligible to qualify as a candidate for the special election on November 5, 2024 to fill the position of Chief of Police of the City of Youngsville, Louisiana, which BOUDREAUX vacated with his resignation in August 2023.

WHEREFORE, Petitioner, DONALD D. LANDRY, District Attorney for the Fifteenth Judicial District of the State of Louisiana, seeks an expedited hearing of this challenge and objection to the candidacy of RICHARD J. BOUDREAUX for Chief of Police, City of Youngsville, Louisiana.

Petitioner further prays as follows:

- a) That in accordance with the provisions of LSA R.S. 18:1406 A, a copy of this Petition be posted in a conspicuous place at the entrance of the Office of the Clerk of Court, Lafayette Parish, Louisiana;
- b) That in accordance with the provisions of LSA R.S. 18:1406 B, Plaintiff be permitted to amend this Petition as necessary and as additional evidence and facts are obtained;
- c) That in accordance with the provisions of LSA R.S. 18:1406 C, the Defendant, RICHARD J. BOUDREAUX, be immediately served with a copy of this Petition, together with a Citation directing him to appear before this Honorable Court no later than 10:00 a.m., on July 25, 2024, to show cause, if any he has or can, why he should not be disqualified as a candidate in the November 5, 2024 primary election for Chief of Police of the City of Youngsville, Louisiana;
- d) That in accordance with the provisions of LSA R.S. 18:1406 D, the Clerk of Court, Lafayette Parish, Louisiana, immediately notify the nominal Defendant, NANCY LANDRY, Secretary of State, by telephone and written notice sent by certified mail that this Petition objecting to the candidacy of the Defendant, RICHARD J. BOUDREAUX has been filed;
- e) That the Defendant, RICHARD J. BOUDREAUX, be ordered to produce at the hearing of this matter all documents and evidence which he believes establishes that he has legally qualified as a candidate for Chief of Police of the City of Youngsville, Louisiana; and
- f) That after all due legal proceedings are had, there be judgment herein favor of Plaintiff, DONALD D. LANDRY, District Attorney for the Fifteenth Judicial District of the State of Louisiana, and against the Defendant, RICHARD J. BOUDREAUX, (1) disqualifying him as a candidate for Chief of Police of the City of Youngsville, Louisiana; (2) compelling the nominal Defendants, LOUIS J. PERRET, Clerk of Court, Lafayette Parish, Louisiana, and NANCY LANDRY, Secretary of State in and for the State of Louisiana, in their official capacities to annul and/or disallow the Defendant, RICHARD J. BOUDREAUX, as a candidate for Chief of Police of the City of Youngsville, Louisiana, (3) forbidding, prohibiting, and/or restraining the placement of the name of the Defendant, RICHARD J. BOUDREAUX, on the

official ballot for the November 5, 2024 special election as a candidate for Chief of Police of the City of Youngsville, Louisiana; and (4) assessing all costs of these proceedings against the

Defendant, RICHARD J. BOUDREAUX.



Dear Ms. Guidry:

In accordance with La. R.S. 18:653, I am enclosing a copy of the notice of resignation received from the Honorable "Rickey" Boudreaux as Chief of Police, City of Youngsville, Parish of Lafayette.

Pursuant to La. R.S. 18:602, the governing authority shall within twenty days (20) days from the date of the vacancy (on or before September 11, 2023):

Make an appointment to fill the office.

• Call a special election. The next available election dates are March 23, 2024 (primary) and April 27, 2024 (general), with qualifying dates of December 13, 14, and 15, 2023. However, in accordance with La. R.S. 18:602(E)(2)(a), you have the option to choose the fall 2024 Congressional election dates, which are currently scheduled for November 5, 2024 (primary) and December 7, 2024 (general), with qualifying dates of July 17, 18, & 19, 2024.

Furthermore, in accordance with La. R.S. 18:1400.1(B)(2), if you choose the fall 2024 Congressional election dates, the State will pick up more than 50% of the costs of ballots and election materials. In contrast, if you choose the spring 2024 election dates, the governing authority will be responsible for all of their costs.

After a proclamation is issued calling the election and an appointment has been made, a certified copy of the proclamation calling the special election as well as the certified minutes of the meeting in which the appointment was made, are to be mailed to our office. A commission will be issued to the person appointed to fill the vacancy.

If the governing authority does not timely call the special election and/or make an appointment, we will forward a request to the Governor to do so pursuant to La. R.S. 18:602(D).
