COUNT 4: in that Allen James Broussard, did willfully, unlawfully, and intentionally tamper with evidence with the specific intent of distorting the results of a criminal investigation or proceeding which may reasonably prove relevant to a criminal investigation or proceeding with the knowledge that such act has, reasonably may, or will affect an actual or potential present, past, or future criminal proceeding, in violation of L.R.S. 14:130.1.A(1) (Obstruction of Justice-Felony)

COUNT 5: in that Allen James Broussard, did willfully, unlawfully, and intentionally tamper with evidence with the specific intent of distorting the results of a criminal investigation or proceeding which may reasonably prove relevant to a criminal investigation or proceeding with the knowledge that such act has, reasonably may, or will affect an actual or potential present, past, or future criminal proceeding, in violation of L.R.S. 14:130.1.A(1) (Obstruction of Justice-Felony)

COUNT 6: in that Allen James Broussard, did willfully, unlawfully, and intentionally ATTEMPT to injure public records by the intentional removal, mutilation, destruction, alteration, falsification, or concealment of any record, document, or other thing, filed or deposited by authority of law, in any public office or with any public officer, in violation of L.R.S. 14:27(132). (Attempted First Degree Injuring Public Records-Felony)




