NARRATIVE

ON 07-25-22 AT 0924 HOURS, I WAS DISPATCHED TO 1109 SOUTH 5TH STREET(STAAB FUNERAL HOME) TO INVESTIGATE POSSIBLE CRIMINAL DAMAGE TO PROPERTY.

WHEN I ARRIVED ON SCENE, I SPOKE WITH [REDACTED] (UNION ROOFER). [REDACTED] IS A REPRESENTATIVE OF CENTRAL IL BUILDING AND TRADES UNION HALL. HE IS PROTESTING STAAB FUNERAL HOME USING NON UNION ROOFERS TO MAKE RECENT REPAIRS TO THE ROOF AT THE BUSINESS. [REDACTED] WAS NOT ON STAAB'S PROPERTY. HE WAS NOT OBSTRUCTING THE SIDEWALK OR ROADWAY. [REDACTED] ALSO HAD A BANNER WITH HIS LOCAL UNION ON IT. ALONG WITH AN INFLATABLE RAT(20 FOOT TALL). WHILE [REDACTED] WAS STANDING BY NEAR HIS BANNER, LAUREN STAAB CAME OUT OF THE BUSINESS WITH A SHARP OBJECT AND PUNCTURED THE INFLATABLE RAT MULTIPLE TIMES. THE PUNCTURE HOLES ARE OBVIOUS. AFTER COMMITTING THE DAMAGE, SHE WENT BACK INSIDE THE BUSINESS. THE ESTIMATED DAMAGE TO THE INFLATABLE IS \$5000.00.

I MADE CONTACT WITH LAUREN INSIDE THE BUSINESS. SHE ADMITTED TO PUNCTURING THE INFLATABLE. SHE SAID, SHE CAUSED THE DAMAGE BECAUSE IT'S EMBARRASSING AND WRONG. I TOLD LAUREN SHE WAS BEING CHARGED WITH DAMAGING THE INFLATABLE. I ARRESTED HER, CHECKED FOR FIT AND DOUBLE LOCKED THE HANDCUFFS. SHE WAS CHECKED FOR WEAPONS WITH NEGATIVE RESULTS. I TRANSPORTED HER TO S.C.S.O. AND RELEASED HER TO C/O KIRBY. I COMPLETED A USE OF FORCE AND BOOKING FORM.
