1 MONTGOMERY: This is Dan.  
2  
3 MADIGAN: Dan?  
4  
5 MONTGOMERY: Yes.  
6  
7 MADIGAN: Mike Madigan.  
8  
9 MONTGOMERY: Mr. Speaker, how are you?  
10  
11 MADIGAN: I'm good. I'm good. How are you?  
12  
13 MONTGOMERY: I'm good, thank you.  
14  
15 MADIGAN: Good. Good. Just to tell you that we had a meeting  
16 with the leaders and the Governor today, and Cullerton's  
17 still in there pitching the tier three.  
18  
19 MONTGOMERY: (Laughs.) I'm, I'm sure he is. (Laughs).  
20  
21 MADIGAN: Yeah.  
22  
23 MONTGOMERY: I mean, we, I don't know what more to do. I mean, we  
24 were explicit, you know, the day we saw you and that  
25 morning with him in opposition to it. Uh, but—  
26  
27 MADIGAN: Right.  
28  
29 MONTGOMERY: —maybe, you know, maybe we'll start talkin' more  
30 pointedly to his caucus, I guess.  
31  
32 MADIGAN: Mmmhmm. Mmmhmm. Mmmhmm. Mmmhmm.  
33  
34 MONTGOMERY: And—  
35  
36 MADIGAN: Now, the, th—, the new revenue estimate coming out of

37 the Governor for tier three is like a hundred and eighty  
38 million dollars. You know, their--  
39  
40 MONTGOMERY: That's tier three savings, a hundred and eighty million?  
41  
42 MADIGAN: Yeah.  
43  
44 MONTGOMERY: Uh huh.  
45  
46 MADIGAN: Rather than the five hundred million of last year.  
47  
48 MONTGOMERY: Yeah, they, their, they saw three hundred and some of  
49 it, how did, what'd they do? Did they, said they  
50 realized, oh, the smoothing. I think maybe the  
51 smoothing. I, I, it, I, I'd have to check this, but  
52 maybe the five hundred million was partially from the  
53 smoothing and partially from tier three estimates.

55 MADIGAN: Mmmhmm.  
56  
57 MONTGOMERY: But, I'd--  
58  
59 MADIGAN: Mmmhmm.  
60  
61 MONTGOMERY: --have to--  
62  
63 MADIGAN: Mmmhmm.  
64  
65 MONTGOMERY: --double check that, so.  
66  
67 MADIGAN: Okay.  
68  
69 MONTGOMERY: Okay. Well, okay. (Laughs) I appreciate the notice on  
70 that. Uh.  
71  
72 MADIGAN: Alright.  
73  
74 MONTGOMERY: I mean, I don't, I don't know if there's anything else  
75 you'd recommend we do, but we'll see.  
76  
77 MADIGAN: Okay. (Unintelligible) you know, I mean, you, just as  
78 you said, you may wanna get active with his members.  
79  
80 MONTGOMERY: Yeah. Yeah, yeah.  
81  
82 MADIGAN: Oh, okay.  
83  
84 MONTGOMERY: Okay. Thank you.  
85  
86 MADIGAN: Alright.

88 MONTGOMERY: Thank you. Bye bye.
