

How to file a comment to PUC before the CCN is issued.

CCN - Certificate of Convenience and Necessity, the first step in the eminent domain process.

PUC has set up 5 official docket pages for comment in response to multiple email inquiries. There will be 1 docket number for each of the transmission lines for the Permian Basin Reliability Project.

Have all the information you want to record and upload ready in a word document, or a pdf. You cannot type your information into a box, it must be an unloadable file, which you will be prompted for at the end of the process. You are given 20 minutes to walk through this process, but it takes about 5 to 10. *Your comments will go on public record.*

Directions:

>Go to www.puc.texas.gov

>In the menu bar across the top, select **Filings**.

>Under Filings, select the top left option **Interchange Filer**.

>Under Get Started click **Begin**.

>In the box labeled **Enter a valid control number for this filing**, you must enter a Docket Number which references a particular project. There have been 5 Docket Numbers assigned each Project Line - pick the Number relevant to your concern.

58561 – Dinosaur to Longshore – CCN Issue Date Feb 2026

CCN 59029 - Longshore to Drill Hole

58559 – Bell East to Big Hill -- CCN Issue Date Mar 2026

58560 – Big Hill to Sand Lake – CCN Issue Date Jan 2026

58545 – Howard to Solstice – CCN Issue Date Feb 2026

Do not check either of the two boxes underneath box where you enter one of the valid Control Numbers.

>Click **Next**.

>Fill in your contact info and click the **Save Contact Information**.

>Click **Next** at the bottom of the page.

>Enter Filing Party Name (your name if you are filing the Comment).

>Filing Type – select Public Comments from the drop down menu.

>Enter Filing Description such as Ratepayer, Landowner, Environmentalist, Protestor, Opposition Statement.

>Click **Next**.

>Click **Add Files** and upload your letter reflecting your concerns.

>Click **Next**.

Almost Done appears. Summary info showing your progress.

>Click **I'm not a robot** at the bottom to verify you are not a scammer.

>Click **Submit**.

You can return to home page and see who has filed on your selected Document Number and what they said. Go back to the main menu page for **Filings**, select **Filings Search** at top of far-right column, and select Electric at the dropdown for **Utility Type** and enter the Docket Number in the box underneath titled **Control Number** and then click **Search** at the bottom of the page.

Send this to everyone you know and get them to fill it out! Even if it is not on your land, we can ALL complain about our electric bills since all electric customers will be paying for this.
