Agricultural District 30-Day Open Enrollment

The 30-day enrollment period for the Agricultural Districts in Wyoming County is from December 1st to December 31st. The Agricultural District Law recognizes that agricultural lands are important and irreplaceable resources. Some of these lands are in jeopardy of being lost as a result of increasing costs of agricultural businesses, development pressures and regulatory constraints. The Law seeks to create economic and regulatory incentives which encourage

farmers to continue farming. Owners of predominantly viable agricultural land that are not already enrolled in an Agricultural District can request to be added to the Districts. All requests are subject to review by the Agricultural Farmland Protection Board, a public hearing, action by the County Board of Supervisors and certification by the State Department of Agriculture and Markets.

NOTICE FOR PUBLIC HEARING ON FIRE PROTECTION CONTRACT FOR 2026

PUBLIC NOTICE IS HEREBY GIVEN, that a Public Hearing will be held Wednesday, December 17th, 2025 by the Town Board of the Town of Batavia, Genesee County, New York, at 7:00 P.M. of that day at the Batavia Town Hall, 3833 West Main Street Road, Batavia, New York, for the purpose of considering contracting with the Town of Batavia Fire Department, Inc. for fire protection services to be furnished by the Town of Batavia Fire Department, Inc to the Fire Department District established in the Town of Batavia and known as the "Town of Batavia Fire Protection District" (hereinafter "District") upon the following general terms, to wit:

1. The Town of Batavia Fire Department, Inc., shall answer and attend upon all emergency calls within said District, and also outside the District when responding as needed pursuant to the Genesee County Mutual Aid Plan.
2. The Town of Batavia Fire Department Inc. shall purchase and maintain the insurances for directors' and officers' liability, general liability, automobile liability, professional liability/errors and omission, and umbrella coverage as set forth in EXHIBIT B attached to the Agreement.
3. The Town of Batavia Fire Department, Inc. shall also indemnify and hold harmless the Town of Batavia, its agents and employees from all claims, suits, loss, damages, injuries, liability, cost and expenses arising from the services provided for in this contract and from the activities of the Fire District, its officers, employees and volunteers to the extent this provision is insured by the Town of Batavia Fire District.
4. The Town of Batavia Fire Department, Inc. shall participate in the Genesee County Mutual Aid Plan and reserves certain rights pertaining to said participation.
5. For such services the Town of Batavia Fire Department shall receive the yearly sum of one million, five hundred ten thousand, one hundred forty-five dollars and fifty-seven cents (\$1,510,145.57).
6. The Town of Batavia Fire Department, Inc., shall provide financial data and records to the Town of Batavia.
7. The Agreement shall run for one (1) year from January 1, 2026, and shall expire on December 31, 2026.
