Section 3-c of General Municipal Law sets a "Property Tax Cap" on the amount that a local government's property tax levy can increase each year. Said cap is 2% or the rate of inflation, whichever is less, with some exceptions. Local communities have the ability to override this cap with the adoption of a local law. ALL PERSONS INTERESTED IN THE SUBJECT MATTER OF THIS HEARING WILL BE ENTITLED TO BE HEARD AT THE TIME AND PLACE THEREOF.
