Final Notice and Public Explanation of a Proposed Activity in the 100- Year Floodplain and/or Designated Wetlands

TO: ALL INTERESTED AGENCIES, GROUPS, AND INDIVIDUALS

This is to give notice that the City of Batavia has conducted an evaluation as required by Executive Orders 11988 and/ or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain and Wetlands Management, to determine the potential affect that its activity in the floodplain and/or wetland will have on the human environment for the Pearl Street Watermain Replacement Project under CDBG CFA No. 149293.

replacement along Pearl Street between River Street and Franklin Street. The proposed project involves the replacement of existing 6-inch diameter water main with ±5,000 linear feet of 8-inch diameter water main. The project also includes the replacement of fire hydrants along Pearl Street.

3602790001B) published by the Federal Government for the City of Batavia, it has been determined that the eastern portion of Pearl Street is located within flood zones A4 (100-year flood zone) and B (500-year flood zone).

Based on Federal and State wetlands maps, it has been determined that an apparent NYSDEC state designated.

determined that an apparent NYSDEC state designated wetland is located at the northeast corner of Pearl and River Streets. The project is expected to disturb less than 0.1 acre in the 100-foot buffer of this State wetland. As a result, the City will comply with Federal requirements regarding floodplain and wetlands management review.

The City of Batavia has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values:

a. Alternative Sites

The proposed improvements have been designed by the Project Engineer based upon the existing condition of water system along Pearl Street. The current water system suffers from age-related deterioration including corrosion and tuberculation resulting in line breaks and loss of flow and pressure. Additionally, the fire hydrants are fed from a common 6" water main that does not meet the current 10 State Standards and do not allow for fire flows to meet minimum Insurance Service Offices (ISO) Standards. These problems cannot be resolved without replacement of the existing water system improvements in the proposed location.

b. Alternative Actions

Alternative actions are defined as: "Actions which are substitutes for the proposed action in that they comprise new solutions or approaches which serve the same function or purpose as that proposed but have less potential for harm."

Alternative solutions and project components were considered during the design process. The existing water system includes aging, deteriorated and undersized water lines. Alternatives to the project as proposed would be the replacement of the existing water lines with equal sized lines; however, this would not eliminate water pressure or fire flow problems that stem from undersized lines. Alternative solutions and project components were considered during the design process. The proposed improvements were selected as the most effective and economical alternative to resolve the existing problems.

c. No Action

Under the no action alternative, the City of Batavia would not undertake the proposed water system improvements to serve the Pearl Street neighborhood. As a result, the residents and businesses of this area would continue to endure poor water quality, water pressure issues, and insufficient fire protection. These conditions would continue to present threats to public health and safety, as water quality and fire protection are essential factors for public health and safety. While taking no action would prevent any potential adverse effect to the floodplains and/or wetlands, it would also preclude the opportunity to provide a reasonable and effective solution to the public health and safety problems confronting residents of the neighborhood.

The City of Batavia has reevaluated the alternatives to construction activities in the floodplain and 100-foot wetland buffer zone. Measures to alleviate or mitigate the potential adverse impacts of the proposed action include:

 a) The City of Batavia will obtain a NYSDEC Freshwater Wetlands Permit (GP-0-25-003) as it is expected to disturb less than 0.1 acre in the 100-foot buffer of the State wetland.

b) Erosion control measures will be implemented to prevent sedimentation in areas of ground disturbance. Disturbed areas will be backfilled, graded, and seeded as quickly as possible following construction to restore the natural value of the wetlands setting.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains and wetlands can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains and/or wetlands, it must inform those who may be put at greater or continued risk.
