Bids for the construction of the Project will be received at the office of the Town of Bethany located at 10510 Bethany Center Road, East Bethany, New York 14054 until August 28, 2025, at 10:00 am local time. At that time the Bids received will be publicly opened and read.

Contract 1: Water Main consists of the installation of approximately 40,000 linear feet of 8-inch and 12-inch water main, valves, hydrant, water services and appurtenances in the Town of Bethany. Contract 2: Marsh Road Water Storage Tank consists of the construction of one (1) 235,000 gallon water storage tank including water main, electrical improvements, SCADA improvements and related work in the Town of Bethany. Bids will be received for 2 separate contracts as follows: Contract 1: Water Main Contract 2: Marsh Road Water Storage Tank
