The work to be performed consists principally of the furnishing of all labor and materials for:

Concrete repairs, wingwall reconstruction, guiderail replacement, drainage improvements and roadway reconstruction. Construction will be on the existing alignments with an off-site detour for each location to maintain traffic during construction.

The forgoing is a general outline of work only and shall not be construed as a complete description of the work to be performed under the Contract.

The project duration is 150 days. All bridge sites shall be substantially complete and open to traffic no later than December 1, 2026. Once work begins on the project, the contractor shall work continuously until all work is complete at all sites.

Bid envelope must have project name, bid date and bid time on envelope.

Bids must be made in writing on the forms furnished and shall be accompanied by a bid guaranty for an amount not less than five percent (5%) of the amount bid in accordance with the Instructions to Bidders. The successful Bidder will be required to furnish and pay for satisfactory Performance and Payment Bonds and provide insurance in accordance with the Instructions to Bidders.

All bids must be accompanied by a Non-Collusion Statement in order to be considered.

Orleans County is an Equal Opportunity / Affirmative Action employer.

The Disadvantaged Business Enterprise Utilization Goal for this project is 5%. The Equal Employment Opportunity goal for Minority Participation is 5.3% and the Women Participation goal is 6.9%. The Proposed DBE Commitment Form must also be included with the bid.

**NOTICE OF ADOPTION OF BOND RESOLUTION
SUBJECT TO A PERMISSIVE REFERENDUM**

At a regular meeting held on the 8th day of September 2025, the Town Board of the Town of Stafford, New York duly adopted a resolution, an abstract of which follows, which resolution is subject to a permissive referendum pursuant to Section 35.00 of the Local Finance Law of the State of New York. If after thirty days of the resolution's adoption by the Town Board, no petition objecting to the resolution and requesting approval by the voters is filed with the Town Clerk of the Town of Stafford, the resolution will be declared duly adopted.

ABSTRACT OF BOND RESOLUTION DATED SEPTEMBER 8, 2025

The following is a summary of a resolution adopted by the Town Board of the Town of Stafford on September 8, 2025. Said resolution authorizes the issuance and sale of a serial bond or bonds, and a bond anticipation note or notes in anticipation of the issuance and sale of said serial bond or bonds, in an amount not to exceed \$400,000. The proceeds from the sale of the obligations authorized in said resolution shall be used for the object or purpose of acquiring one (1) 10-Wheeler Dump Truck with Snowplow/Box Package and one (1) 6M 116 Cab Utility Tractor related equipment and apparatus and the payment of the costs of issuance of the bonds and bond anticipation notes issued to finance such acquisition. The estimated maximum cost of said object or purpose is \$439,332, and the period of probable usefulness thereof is fifteen (15) years. The Bonds have a proposed maturity of more than five years to be measured from the date of the Bonds or from the date of the first bond anticipation note issued in anticipation of the sale of such Bonds, whichever date is the earlier.
