NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board of the Town of Wethersfield at the Town Office located at 4362 Route 78, Gainesville, New York, on the 6th day of November , 2025 commencing at 6:45 p.m. to give citizens the opportunity to consider a proposed local law that will allow the Town Board to adopt a budget for the fiscal year 2026 that requires a real property tax levy in excess of the limit specified in General Municipal Law Section 3-c.

Section 3-c of General Municipal Law sets a “Property Tax Cap” on the amount that a local government’s property tax levy can increase each year. Said cap is 2% or the rate of inflation, whichever is less, with some exceptions. Local communities have the ability to override this cap with the adoption of a local law.

ALL PERSONS INTERESTED IN THE SUBJECT MATTER OF THIS HEARING WILL BE ENTITLED TO BE HEARD AT THE TIME AND PLACE THEREOF.
