October 25th, 2025: The Wyoming Co. Soil & Water Conservation District (SWCD) will receive sealed bids for the Engineering Services for the Upper Tonawanda Creek Water Quality Improvement Project. Sealed Bids will be due and publicly opened and read at the following location and time: **Wyoming Co. SWCD Office, 36 Center Street, Suite D, Warsaw, NY 14569. Date: Monday, November 24th, 2025. Time: 10:00 AM.**

The project requires engineering services necessary to implement a fully designed streambank stabilization project on a severely eroded segment of the Tonawanda Creek. In 2024, the SWCD hired an engineering consultant to facilitate a topographic survey, geotechnical investigation, and provide 100% complete engineered designs for construction bidding. These designs were utilized to secure federal funds and must be followed as designed to retain funding. The SWCD requires additional engineering services including but not limited to: completion of HEC-RAS Hydraulic Modeling, Preparation of a FEMA no-rise analysis, certified wetland delineation, application and correspondence with regulatory agencies for permitting, management of all National Historic Preservation A Section 106 requirements, finalized construction bid package, and construction oversight and inspection during construction.
